<u>CD1 TO RESOLUTION 23-2</u> (Approved by the Committee at its January 10, 2023 meeting) – The CD1 (OCS2023-0024/1/11/2023 10:46 AM) makes the following amendments:

A. In the ninth WHEREAS clause, adds the phrase "through the State and Local Fiscal Recovery Fund ('SLFRF')" in order to clarify that the ARPA funds are from the SLFRF category.

- B. After the ninth WHEREAS clause, adds four new WHEREAS clauses in order to comply with the requirements for reprogramming under Section 17 of Ordinance 22-14 (Executive Capital Budget Ordinance for Fiscal Year 2023), including:
 - 1. Identifying the projects from Appendix A to Section 17 of Ordinance 22-14 that will be utilized to provide the reprogrammed funds and how much will be deleted from each source project; and
 - 2. Adding information regarding: (i) the City department requesting the funds for the project; (ii) the ARPA Recovery Plan subcategory, ARPA Fiscal Recovery Fund ("FRF") expend category, and the FRF expend subcategory; (iii) the project description; (iv) the expected time period for the expenditure of the funds for the project; and (v) an explanation for why ARPA monies received during Fiscal Year 2021 are insufficient to cover the scope of the project proposed for reprogramming.
- C. Revises the BE IT RESOLVED clause to make the Council's approval of the reprogramming described in the resolution contingent upon the Council's receipt of a Housing and Homeless Program Plan not later than 90 days following the adoption of this resolution.
- D. Adds a BE IT FURTHER RESOLVED clause to read as follows:

"BE IT FURTHER RESOLVED that the Council, upon approval of the reprogramming of said funds, authorizes the Director of Budget and Fiscal Services to implement the reprogramming, receipt, and expenditure of said funds in accordance with this resolution, and execute any incidental or related amendments, agreements, or documents in furtherance of any reprogramming actions; and"

E. Makes miscellaneous technical and nonsubstantive amendments.

PROPOSED CD1 TO RESOLUTION 23-2 (Submitted by Councilmember Cordero) – The CD1 (OCS2023-2023-0070/1/31/2023 2:18 PM) makes the following amendments:

- A. In the ninth WHEREAS clause:
 - 1. Deletes the \$33,000,000 amount of ARPA-SLFRF funds; and

- 2. Adds the phrase "through the State and Local Fiscal Recovery Fund ('SLFRF')" in order to clarify that the ARPA funds are from the SLFRF category.
- B. After the ninth WHEREAS clause, adds four new WHEREAS clauses in order to comply with the requirements for reprogramming under Section 17 of Ordinance 22-14 (Executive Capital Budget Ordinance for Fiscal Year 2023), including:
 - 1. Identifying the projects from Appendix A to Section 17 of Ordinance 22-14 that will be utilized to provide the reprogrammed funds and how much will be deleted from each source project; and
 - 2. Adding information regarding: (i) the City department requesting the funds for the project; (ii) the ARPA Recovery Plan subcategory, ARPA Fiscal Recovery Fund ("FRF") expend category, and the FRF expend subcategory; (iii) the project description; (iv) the expected time period for the expenditure of the funds for the project; and (v) an explanation for why ARPA monies received during Fiscal Year 2021 are insufficient to cover the scope of the project proposed for reprogramming.
- C. Revises the BE IT RESOLVED clause to include approval of reprogramming of \$10,000,000 of the following monies to support the Rental and Utility Relief Program:
 - \$8,000,000 of the remaining balance of the undesignated ARPA-SLFRF monies appropriated in Ordinance 22-14; and
 - \$2,000,000 of Project Number 1 monies.
- D. Adds a new first BE IT FURTHER RESOLVED clause to approve the reprogramming of \$4,000,000 of monies, consisting of \$3,000,000 of Project Number 1 monies and \$1,000,000 of Project Number 39 monies, on the condition that the City Administration submit to the Council a Housing and Homeless Program Plan not later than 90 days following the adoption of the resolution.

E. Adds a second BE IT FURTHER RESOLVED clause to read as follows:

"BE IT FURTHER RESOLVED that the Council, upon approval of the reprogramming of said funds, authorizes the Director of Budget and Fiscal Services to implement the reprogramming, receipt, and expenditure of said funds in accordance with this resolution, and execute any incidental or related amendments, agreements, or documents in furtherance of any reprogramming actions; and"

F. Makes miscellaneous technical and nonsubstantive amendments.
