In accordance with Section 9-102.1, Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended, and in anticipation of the Budget Committee's upcoming deliberations of the FY 2024 Operating and Capital budgets, please submit **27 copies** of the following budget related documents to the Budget Committee Aide, Ms. Darcie Nago by Thursday, March 2, 2023 (for your reference, the FY 2023 budget cycle communication number has also been provided):

- 1. Executive Operating Budget Bill and the accompanying Operating Program and Budget Book (Volume 1) (Mayor's Message 33 (2022), dated March 2, 2022 ("MM-33 (2022)").
- 2. Executive Capital Budget and the accompanying Capital Program and Budget Book (Volume 2) (MM-33 (2022)).
- 3. General Obligation Bond Issuance and Sale Authorization Bills (MM-33 (2022)).
- 4. Real Property Tax Rates Resolution (MM-33 (2022)).
- 5. Recommendations to FY 2023 Fees and Charges, as required by Section 2-4.2, Revised Ordinances of Honolulu 2021 ("ROH") (MM-33 (2022)).
- 6. Farebox Recovery Ratio for TheBus, as required by Resolution 19-10 (MM-33 (2022)).

- 7. Initial Tax Rate and Real Property Net Revenue Percent, pursuant to Ordinance 06-10 and Resolution 07-60, CD1, respectively (MM-33 (2022)).
- 8. Operating Budget Line-Item Details, Departmental Communication 148 (2022), dated March 2, 2022, ROH Section 2-18.6 requires the submission of line-item budget details for each budgeted activity in the Operating Budget according to salary, current expense, and equipment expenditure categories. ROH Section 2-18.6 further states that the line-item budget details for salary cost items must include, but not be limited to, the class description of budgeted positions. Please ensure that the Position Summary by Classification includes all permanent, temporary, and contract positions.
- 9. Operating Budget Details of Line Items Exceeding \$50,000, Departmental Communication 149 (2022), dated March 2, 2022, ROH Section 2-18.6 states that for current expenses and equipment items, exceeding \$50,000 in the Operating Budget, additional information must be provided, including a clear description and purpose of the budgeted items and/or services. Please ensure that items are *not* lumped together under object code.
- 10.1 Position Vacancies Report, Departmental Communication 150 (2022), dated March 2, 2022, ROH Section 2-18.7 requires that a position vacancy report be provided to the Council. Please ensure that this report is detailed by department and activity and should also include the current balance of the Provision for Vacant Positions, as well as the number of positions filled to date using the provisional funding.
- 11. Capital Budget Line Item Details, Departmental Communication 151 (2022), dated March 2, 2022, ROH Section 2-18.6 states that for each miscellaneous project, exceeding \$50,000 in the Capital Budget, additional line item details must be provided. Please ensure that a brief narrative explanation of how the funds will be used for each project is included.
- 12. Inventory of Fees, Departmental Communication 152 (2022), dated March 2, 2022, fees and charges for each City department for the City services levied by their department. The listing of fees should include the amount of the fee or charge, its purpose, the rationale and cost elements included in the development of each fee or charge, the date the fee was initiated or last increased, and the estimated total annual revenue of the fee. To ensure a uniform submittal of this information, please have each City department use the example attached to this communication (Exhibit A). Additionally, please use the updated ROH citations as listed in the attached "User Fees and Charges Citations" (Exhibit B).

Thank you for your cooperation and I look forward to working with the City Administration during the upcoming FY 2024 budget cycle.
