




# Compliance

- The park is in full compliance with the:
  - U.S. Department of Agriculture Animal Welfare Act
  - National Oceanic and Atmospheric Administration's Marine Mammal Protection Act
  - Requirements of the National Marine Fisheries Service with regards to the care of captive marine mammals
- The park is in possession of the permit required under the Migratory Bird Treaty Act (MBTA) and Endangered Species Act of 1973, required for all conservation, education and outreach activities relating to birds.

# **Environmental Education**


- Exhibits, signage, and opportunities for educational interactions with the animals

  - Honu loaned to these locations
  - Thousands of people learn about honu through those partnerships


