WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy allows for the acceptance of gifts by the affirmative action of the Council; and

WHEREAS, through a letter dated February 7, 2023, approved by the Managing Director, the Fire Chief has submitted a request to the Council for acceptance of a gift to the City from The 200 Club of \$4,000 to fund the Honolulu Fire Department's Manager, Fire Fighter, and Civilian Employees of the Year awards; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift form attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body gratefully accepts the gift valued at \$4,000 from The 200 Club that is more fully described in the above-referenced letter dated February 7, 2023, and the Declaration of Gift form attached hereto as Exhibit A; and


