3. **RESOLUTION 22-250 – ESTABLISHING A NEW WAI'ANAE PATROL DISTRICT.** Urging the Honolulu Police Department and the Administration to establish a new Wai'anae Patrol District 9 by 2024 and requesting that it consider providing officer recruitment and retention incentives.

4. **CC-46 (2023) – DRAFT COMMITTEE REPORT ON THE REVIEW AND EVALUATION OF THE CITIZENS ADVISORY COMMISSION ON CIVIL DEFENSE PURSUANT TO ORDINANCE 17-44, CODIFIED AS CHAPTER 3, ARTICLE 15, REVISED ORDINANCES OF HONOLULU 2021, AS AMENDED.** The Committee will take action on a draft committee report making recommendations to the Council on whether the Charter provisions establishing the Citizens Advisory Commission on Civil Defense should be retained, amended, or repealed.
