In response to councilmembers, Chief Arthur Logan, Honolulu Police Department stated that:

 In order to obtain a conceal/carry license, applicants need to obtain a permit for the firearm, go through a background check, a mental health check, obtain a certification of proficiency with the firearm, pay the license fee, and complete a fourhour class.

- He trusts the process of obtaining a conceal/carry license. HPD issued 30 licenses to carry and none of the applicants have been arrested for committing a crime with a firearm. The first license was issued towards the end of December 2022. There were over 600 applications that were received by HPD.
- Each state has a different approach on the Second Amendment.
- He supports the intent of the Bill but has some concerns with enforcement. He stated that the penalties for breaking the law in the Bill are sufficient and if it becomes law, HPD will enforce it.
- The Bill is designed to prevent anyone from carrying a firearm into any business or establishment that does not allow guns.
- Signs stating whether or not guns are allowed are an important tool for HPD.
- HPD does not know where all the City owned and/or controlled buildings are located.
- If you have a conceal/carry license, it is your choice if you want to carry the gun.
- A license to carry permit requires four hours of classroom training with a written test that covers the laws and use of force (HRS Chapter 703), how to operate a gun, the proper storage of a gun, how to lock up the firearm safely in your car, and storing the ammunition separately from the gun.
- Training on how someone carrying a gun should interact with law enforcement is not required at this time but in conversations with members of the Coalition for Firearms, they are training their members to understand that they should follow what the officer is saying.
- There will be consequences should a firearm be used by a person licensed to carry.

In response to councilmembers, Daniel Gluck, Corporation Counsel, Department of the Corporation Counsel stated that:

- There have been court challenges to sensitive places legislation in New York, New Jersey and one other state that he does not know off hand.
- Two Federal district courts have granted injunctions. A Ninth Circuit or the Supreme Court decision would determine how sensitive places would be interpreted and applied in Hawai'i.

- If a lawsuit is filed in a Federal court in Hawai'i, that court is bound by rulings of the U.S. Supreme Court and the Federal Ninth Circuit Court of Appeals. District court decisions may be resources for Hawai'i judges but are not binding.
- Pending State legislation would address sensitive places but it is unclear whether that would preempt City action.
- There is no current law in place prohibiting a license concealed and carry permit holder from carrying a firearm in a public place.
- Bill 57 would add criminal penalties to someone bringing a gun onto private property.

In response to councilmembers, Krishna Jayaram, Deputy Managing Director stated that:

- This is a legally driven Bill and the Administration wanted to take action to keep gun violence low in our City.
- Under the current Bill, guns would not be allowed on TheBus.
- The Administration has engaged with the business community and asked them to provide their feedback regarding signage directly to the City Council.

In response to Chair Waters, Major Trinidad stated that in a routine traffic stop, HPD would run a check in their system to see if the person has a driver's license and the system would signal if that person has a license to carry with all the pertinent information.

Councilmember Kia'āina stated that she supports policies that advance gun safety and violence prevention as outlined in Bill 57. She noted that she will craft a CD2 that includes an expanded list of sensitive places and looks forward to a robust discussion in Committee.

Councilmember Tupola stated her opposition to Bill 57. She noted that the definition of sensitive places is too broad and undefined. Councilmember Tupola quoted the Bruen case in the CD1 that she proposed. She stated that Bill 220 on Hawai'i Island was not signed by their Mayor because it was confusing, extended rights too far, appeared to violate Federal law and that future gun legislation should be enacted at the State level. Councilmember Tupola stated that SB1230 is moving and covers all of the places and more.

Councilmember Tulba stated that he will be voting no on the measure. He noted that the second amendment gives individuals the right to defend themselves outside of their homes and the Bill makes it harder for law abiding citizens who are licensed to exercise this constitutional right. Councilmember Tulba also stated that the Bill is broad and confusing and will have legal challenges.

Councilmember Okimoto stated that hearing all the discussions shows that this is a very sensitive issue and she will vote in opposition of the measure. She stated that Bill 57 is both unconstitutional and overreaching for the City Council and the issue would be best taken up by the State Legislature. Councilmember Okimoto noted that the Bill is likely an infringement on second amendment rights and imposes an undue burden on ordinary law abiding citizens who have a constitutionally protected right to carry a handgun for self-defense outside the home. She believes that HPD Administrative Rules regulating the issuance of permits are more than sufficient to protect the communities until the State is able to pass a Bill that is constitutionally sound.

#### THIRD READING

A BILL FOR AN ORDINANCE RELATING TO SHORELINE SETBACKS.

Councilmember Kia'āina moved that Committee Report 32 be adopted and Bill 41 (2022), CD1 pass third reading as amended to CD2. Seconded by Councilmember Cordero.

In response to councilmembers, Dawn Takeuchi Apuna, Director, Department of Planning and Permitting (DPP) and Elizabeth Kruger, DPP stated that:

- When Act 16 passed in September 2020, permit applications increased by about 85 percent.
- The DPP is asking for approximately three to four new positions for the Sea Level Rise Branch and that would also cover flood policy issues.
- The DPP can provide more public outreach and informational briefings. The public can call or email the DPP as they have planners available to answer questions.
- Information on shoreline issues will be added to the DPP website and commercials will explain shoreline requirements.
- There are two types of Special Management Area (SMA) permits. The SMA major permit is approved by Resolution and has a two year deadline to obtain a development permit. The DPP is allowed to extend the deadline for one year and if needed the applicant can ask the Council for a further extension. The SMA minor permit covers less expensive dwellings and usually does not have a deadline.

Councilmember Kiaʻāina stated that it was important for her to work with all stakeholders and the City Administration to provide amendments that would mitigate the impacts of the policies that would affect the shoreline ohana, including those with multi-generational ties. She stated that Bill 41 would update the City shoreline setback laws by incorporating amendments made by Act 16 to the State Coastal Zone Management Law and implement a new erosion rate based on a shoreline setback formula. Councilmember Kiaʻāina explained her CD2 amendments and how it will affect those in the community.

Councilmember Weyer expressed his appreciation to Vice-Chair Kia'āina and her staff for working on both bills to meet the needs of the community and climate change.

Chair Waters echoed the comments of Vice-Chair Kia'āina and thanked her for her hard work on the Bill.
