Mobile Commercial Establishment. A vehicle with current registration and safety check used by an itinerant vendor for the sale of food products or other wares. The vehicle must be mobile and in a condition that allows it to enter and exit the zoning lot. The term includes trailer attachments, push carts, lunch wagons or vans, shipping containers, food trucks, and pop-up tents. The term does not include vendors at farmers' markets, fun fairs, special community events, or other special events where mobile commercial establishments do not constitute a majority of the event, or are managed by a regulatory entity.
