I oppose the portion of Bill 19 (2023) that would eliminate the current protections of ROH 10-1.2(h) which prohibit commercial activities at Kailua and Kalama Beach Parks in Kailua.

On April 5, 2012 the Kailua Neighborhood Board passed a Resolution that "The Kailua Neighborhood Board No. 31 supports a version of City Council Bill 11 (2012) that includes prohibitions of commercial vendors and commercial buses in Kailua and Kalama Beach Parks".

City Council Bill 11 (2012) was subsequently passed in 2012 which added the following language to ROH 10-1.2(h):

"(h) Commercial activities prohibited at parks.

- (1) Commercial activities, including recreational stops by commercial tour companies, but excluding commercial filming activities that take place from 1:00 p.m. on Saturdays through 6:30 a.m. on Mondays, are not allowed at any time at the following parks:
- (A) Kailua Beach Park; and
- (B) Kalama Beach Park."

Prior to the implementation of Bill 11 (2012) Kailua Beach Park was being overrun with commercial kayak and tour bus activity.

The wisdom of Bill 11 (2012) banning commercial activity at Kailua Beach Park was borne out by the Windward Oahu Tourism Assessment conducted by the University of Hawaii's Center for Sustainable Coastal Tourism under a Sea Grant program initiated by former Councilman Ikaika Anderson. This assessment found that Kailua Beach Park was about 50% more crowded in 2019 than it was in 2007. Their large sample surveys in 2019 found that Kailua Beach Park is at the cusp of reaching >50% dissatisfaction with the amount of overcrowding. Our infrastructure at Kailua Beach Park is that of a small residential town which is not geared for commercial activity. The University of Hawaii study puts crowding at Kailua Beach Park at a tipping point. The doubling of the number of people on the beach from 2007 to 2019 puts us at an effective maximum ceiling – as more people or activity would measurably degrade the experience for residents and visitors alike. Clearly a resumption of commercial activity that would take up parking and beach space and compete with family recreational activity would put us past the tipping point.

Unfortunately, City Council Bill 19 (2023) threatens to do just that. Bill 19 (2023) would eliminate the current protections of ROH 10-1.2(h) and replace it with provisions that would allow the Department of Parks and Recreation to issue permits to authorize commercial activity at Kailua and Kalama Beach Parks in Kailua.

Bill 19 (2023) must be amended to retain the existing ROH 10-1.2(h) prohibition of commercial activity at Kailua and Kalama Beach Parks.

Testimony:  I have enjoyed our beach parks as a Kailua resident since the 1980s. When I was in college and looking for part-time work, I worked out of a truck parked within Kailua Beach Park and offered kayak, windsurfing, and kiteboarding experiences. Years later, my community and I expressed our concerns about the commercialization of our beach parks. We were successful in prohibiting all commercial activities. Since then, members of our community have been seen participating in a variety of beach and ocean activities. There are times when tourists appear to dominate the parking, beach, and even ocean areas, but for the most part, residents and tourists coexist. A bill repealing the bans on commercial activities in beach parks would be detrimental to this balance. I could have never imagined that I would be back in council chambers so soon since it's only been four months since we were celebrating the passage of bill 48. It will come as no surprise that I strongly oppose Bill 19 as it is currently written - specifically as it relates to recreational stops by tour buses.

Bill 48 was passed late last year providing a sense of balance between the needs of local residents against the increasing incursion of tourism in all of our communities. Last year you allowed our voices to be heard and our needs considered as

residents living in neighborhoods where beach parks exist. You enabled us the chance to protect our essential park and beach while keeping it accessible to the many residents, locals and other visitors that enjoy it. Bill 19 undoes that progress.

First, it's a one size fits all approach that does not account for the uniqueness of local communities and once again opens up a free for all for commercial tour buses to come and go as they please. If you think they won't, you will be mistaken.

Second, the complicated and detailed rules set forth, while commendable, are unenforceable. Right now at Kokololio there is no enforcement of any rules, ever. Signs are ignored by tourists and locals alike. We already deal with rules being broken every day: illegal camping, smoking, vaping, loud music on the beach, litter, dogs off leash, motorcycles, atvs in the park and on the beach, never mind actual crimes of drug use, assault and other crimes. We only have 4 police up here on the north shore and they are already quite busy. When they are called for issues at Kokololio, they frequently don't show, don't cite when they do, or show up too late. To expect the police to know all the rules of this bill, then show up for too many buses or too many people is a waste of scarce and valuable resources. Furthermore, it is unreasonable and unfair that residents should be responsible to monitor everyone's behavior and contact the police for infractions. Honestly, it would be a part time job!

Finally, the relatively low fines will not deter bad actors and would disproportionately affect the smaller operators. The larger businesses can more easily violate the rules and just bake citation costs into their prices.

Bill 19 in its current form is a free pass for commercial tour operators to visit any and all 61 beach parks five days a week (the idea of no weekends and holidays is a good one in general, btw). We would ask that the beaches that were offered protection through bills 38 and 48 be given an exception in your new plan. Mahalo nui loa.

I am somewhat in favor of this bill in that we need an island-wide policy instead of the cascade of bills that have banned all of the beaches in Kailua, and then Waimanalo, then the North Shore, then Kokololio. Remember those photos during Covid of all those rental cars parked at Aloha Stadium. Tour companies help to alleviate traffic by having less cars on the roads. Tour companies provide local jobs for drivers and tour guides. Tour guides keep the visitors safe, and educate them on the history and culture of Hawaii, and prevent them from doing things that they shouldn't do like climbing on cultural sensitive sites, and leaving trash behind. These are things that they don't get when they take a rental car out on their own. These laws have actually made the problems that we are trying to solve, worse. Besides all of these beaches that tour companies are banned from, they are also banned from all of the state parks, including state beach parks, and also 2 of the botanical gardens, and all but 7 hiking trails managed by DLNR. When tourists find out that they can't go to these places with a tour guide, they'll just get rental cars and go there on their own, usually 2 people per car, and when the rental cars run out, they'll just get one on the Turo app, and then we have no idea how many rental cars are on the road. Most people look at this as banning the tour companies, like they're the bad guys, but these laws are actually discriminating against a certain kind of visitor. A lot of my guests are elderly and don't feel comfortable driving in a strange place. These laws discriminate against them, preventing them from going to certain places that any other person without a tour guide can go. We also get a lot of visitors from countries that drive on the other side of the road, like Australia and Japan, and would rather have a tour guide drive them, than risk driving a rental car. These laws discriminate against these people as well. We do need Rules, but these rules are too restrictive, and make the problem that we are trying to solve, even worse. Most tour companies have an itinerary that they are trying to keep to on their 8 hour, 120 mile Circle Island Tour, so when they do stop at a beach park, it's usually not for very long, because they have a schedule that they're trying to keep to. However, when a tourist with a rental car goes to the beach, they're going to pack a lunch, lay out a towel, and stay for hours, taking up a parking space for a rental car that had just 2 people per car. There have been some bad actors that have caused the community to be upset at the tour companies, but if the City would have been enforcing the rules that are already in place, then we wouldn't be where we are now. In the 12 year history of my company, and going down the Parks Department every month to get permits, not once has an official asked to see my permit. I maintain on our webpage, a list of all the places that tour companies are banned from, it's ridiculous, and the list just keeps getting longer.

In 1990 I was living across the street from Kailua beach and witnessed the first tour buses empty visitors. These buses grew from a few to many while the visitors numbered a several hundred to thousands. Neighbors testified at neighborhood and city council meetings asking that these commercial activities be banned as we were being inundated with strangers asking to use our household bathrooms, or leave their trash on our beaches and yards. Used diapers were often left along with plastic food and water containers, straws and other debris. As a neighborhood caretaker of Kailua beach I saw firsthand how Hawaii's environment was being trashed. When I spoke out at a neighborhood meeting with Kailua representatives, I was told that "you need to be aware of what side your bread is buttered on." That comment came from a resident who was running many beach rentals. While that was my first introduction to the commercialization of Kailua Beach, his comment saddens me even more today.

Be wary...once the door to commercialization of a natural beach is opened, there is no turning back. Today social media will find a way, in the same way the moneymakers will and have.

In my experience, what started as a few buses and kayaks grew to thousands of people inundating previous environmental areas stomping endangered corals and nests. We saw this happen on Flat Island and the Mokuluas. When the buses were banned, the buses then dropped off their riders in Kuulei and Lanikai. So we had to speak up again to prevent these dropoffs. Then the buses morphed to vans to get around these new restrictions. All this sneakiness to

make money off the beaches in neighborhoods where children walk or ride bikes to school and residents battle sometimes hours of traffic to get to work and other regular life moments.

You have the power to prevent these environmental and safety issues occurring on and around the beaches of Kailua and Waimanalo. Use your ability to be a caretaker of our environment and communities. Exempt Kailua and Waimanalo beaches as well as all natural beaches from commercial activities.

Aloha Chair Tulba and Councilmembers,

I would like to comment on bill 19 and changes proposed by this committee and the current administration.

An island-wide policy to manage and regulate commercial activities in all Oahu city parks will be difficult. Certain beach parks were created under special circumstances therefore cannot be managed under rules that pertain to other parks.

Kailua Beach Park comes from private lands condemned by executive order under Governor Farrington in 1922. Many Kailua families were displaced to create this public resource. The EO was made upon the express condition that the city must maintain the land for public purpose and only for use as a park. Commercial use for private gain is not the purpose or intention of public parks.

I was involved with policy changes for both Kailua and Waimanalo during Councilmember Andersons time as the windward representative. In 2010, all of our district lawmakers (both City and State) supported a commercial activity ban in Kailua due to hundreds of complaints by constituents over many years. Following numerous public hearings, hours of testimony, and the councils override of a Mayors veto, this legislative body enacted Ordinance 12-22 knowing it would set precedent for parks islandwide.

Prior to that, the City Council faced testifiers in 1996. An Environmental Assessment was conducted to expand Kailua Beach Park

and private land was condemned for a second time. Initial plans for the expansion included a large parking lot and tour bus parking. The EA documents testimony by the Director and administrators stating tour buses and commercial activity would not be allowed at Kailua Beach Park. The EA was approved by the City Council and the park was expanded to what it is today. The proposed parking lot was replaced with wide open green space and picnic tables. Testimony by the Parks Director stated limited parking will naturally limit the amount of park users coming to Kailua Beach Park and prevent overcrowding.

Today we are once again faced with proposals for recreational stops by tour vehicles at Kailua Beach Park. The existing EA does not allow any kind of commercial permits and another EA would need to be conducted in order to assess the effects of new activities. Ordinance 12-22 that originally banned commercial activities from Kailua and Kalama beach park merely codified findings of the EA and the parks purpose. As a community, we knew that with each incoming administration, the history of the EA would eventually be lost therefore pushed for those stipulations to become permanent policy. Yet, here we are again.

Waimanalo faces similar circumstances. In 2004, Resolution 04-37 was passed by the City Council authorizing the mayor to enter into License Agreement No. 547 which transferred the management, operation, and maintenance of beach parks located on Hawaiian homelands from DHHL to the City. The parks affected by this agreement are Waimanalo, Kaiona, Kaupo, Makapuu, and Nanakuli. As a result of this agreement, permits for commercial recreational stops are prohibited. Prior to CM Anderson introducing bill 8 in 2015 (Ordinance 17-3) it was already illegal for tour vehicles to enter Waimanalo parks and the bill codified existing rules.

Commercial use of city parks is a privilege, not a right. An island wide rule easily enforced is no commercial activity in city parks. If permits are considered, they should be vetted through the authorized activity designation process for that particular park. Kailua and Waimanalo parks cannot be used for recreational stops for reasons beyond the control of this council which is why exemptions should remain in ROH Chapter 10.

However the Kailua Neighborhood Board isn't happy about Kailua's popularity. It passed a resolution urging the Hawaii Tourism Authority to stop promoting Kailua as a tourist destination.

"Be it resolved that the Kailua Neighborhood Board asks the Hawaii Tourism Authority to respect the zoning and quality of life of our residential neighborhoods and immediately stop promoting Kailua as a tourist destination and alternative to Waikiki," the resolution said.

"We feel that we need to have areas on the island where local people can live and not be inundated like animals in the zoo where people come look at us. This is a residential community. We want to raise our children and the tourist areas are designated elsewhere on the island," said Chuck Prentiss, Kailua Neighborhood Board Chair.

Prentiss says tourists attract more thieves which brings crime, as well as traffic and increased housing prices. He also says the Hawaii Tourism Authority should not encourage Kailua vacation rentals when bed and breakfasts established after 1989 are not allowed.

"We feel very strongly that the position of the board is what the community wants," said Prentiss.

The council's Parks and Cultural Affairs Committee traveled to Kailua to hear testimony on the new measure, Bill 11 CD1, which was introduced by area councilman Ikaika Anderson.

"They were loud and clear when they came out to a meeting, I had about a month ago. A hundred plus community members said 'Ikaika, we don't want any commercial activity, we don't want any tour bus activity, and we want you to take that back to the council," he said.

More than 200 people, including current and former area state lawmakers, came to support the bill.

"Kailua is not Waikiki," Rep. Chris Lee (D-Keolu, Lanikai, Waimanalo) told the council committee. "We do not have the infrastructure to support the increased commercial use here that we've seen in recent years." The remark drew cheers and applause.

Several of those who testified were especially against kayak rental companies at the beach parks. "The island bird sanctuaries of Popoi'a (Flat Island) and Moku Nui have lava rock shorelines except for one small sandy beach, which can fill up quickly with a single kayak tour. However, there are seven companies selling tours," said Lisa Miller.

"Many people have a deep spiritual connection to Kailua Beach," said resident Lisa Cates. "Many go there to connect with loved ones whose ashes are scattered there, and to see it exploited for monetary gain is hurtful."



Also, at our meeting on Thursday, 4/6/23 an individual motion is proposed for consideration:

The Kailua Neighborhood Board opposes the portion of Bill 19 (2023) that would eliminate the current protections of ROH 10-1.2(h) which prohibit commercial activities at Kailua and Kalama Beach Parks in Kailua. On April 5, 2012 the Kailua Neighborhood Board passed a Resolution that "The Kailua Neighborhood Board No. 31 supports a version of City Council Bill 11 (2012) that includes prohibitions of commercial vendors and commercial buses in Kailua and Kalama Beach Parks". City Council Bill 11 (2012) was subsequently passed in 2012 which added the following language to ROH 10-1.2(h): "(h) Commercial activities prohibited at parks. (1) Commercial activities, including recreational stops by commercial tour companies, but excluding commercial filming activities that take place from 1:00 p.m. on Saturdays through 6:30 a.m. on Mondays, are not allowed at any time at the following parks: (A) Kailua Beach Park; and (B) Kalama Beach Park." Prior to the implementation of Bill 11 (2012) Kailua Beach Park was being overrun with commercial kayak and tour bus activity. In 2019 Kailua Beach Park was determined to be at the tipping point for overcrowding, with twice the use of the beach as there was in 2007. Clearly a resumption of commercial activity that would take up parking and beach space and compete with family recreational activity would put us past the tipping point. As currently written, City Council Bill 19 (2023) threatens to do just that. Bill 19 (2023) would eliminate the current protections of ROH 10-1.2(h) and replace it with provisions that would allow the Department of Parks and Recreation to issue permits to authorize commercial activity at Kailua and Kalama Beach Parks in Kailua. **The Kailua Neighborhood Board strongly urges the City Council to** amend Bill 19 (2023) to retain the existing ROH 10-1.2(h) prohibition of commercial activity at Kailua and Kalama Beach Parks.



#### Testimony for the City Council; Honolulu, HI; by Barbara Mayer; Wednesday, April 5, 2023:

My name is Barbara Mayer, retired teacher, and year-around resident of Waimānalo since 1976. I'd like to take a position on the proposed CD1 for Bill 019(2023) relating to commercial activities at public parks & beaches.

# I oppose Bill 19; am in favor of CD1.

(1) Firstly, in Bill 19 I am in favor of deleting the repeal of §§ 10-1.2 (h) and (i). I am in favor of deleting the repeal of commercial activities, including recreational stops and certain commercial filming activities, at certain City-managed beach parks, including in Waimānalo and Kailua, and City-managed rights-of-way.

I believe the stated commercial activities do not belong in or around beach parks; these activities should be prohibited. There should be no repeal of the prohibitions. Therefore, delete the repeal of prohibitions of commercial activities.

(2) Secondly, complete the job by amending Section 10-1.3(a)(13) to read "Recreational stops of any length of time at any beach park or beach support park; except that no permits may be issued for recreational stops prohibited by §§ 10-1.2(h) and (i)".

Eventually, I would like to see laws prohibiting commercial activities of all sorts at all parks & beaches across the state. But in the meantime, <u>I want to retain the protections we have in place for Waimānalo and Kailua and City-managed rights-of way.</u>

# Written Testimony OPPOSING Bill 19 (2023) Submitted by Sarah Gilman Sur, 12A Kailua Road

Aloha. I am submitting written testimony OPPOSING Bill 19 (2023) relating to public parks. I live on Kailua Beach (behind Kalapawai Market and right at the entrance to Kailua Beach Park). My family has resided on our property since the 1930's. We have seen first-hand how previous commercial operators (kayak rental and wind surfing companies and tour buses in the 90s) took over the beach park, destroying the "small-town feel" of Kailua as we knew it. In 2012, the grassroots efforts of the Kailua community testified with a resounding "NO!" to allowing the continuation of commercial activity at Kailua and Kalama Beach Parks. As a result, former Mayor Carlisle's veto was overturned and Bill 11 passed. In 2022 (a little over a year ago!), our brothers and sisters in Waimanalo stood up and said, "NO!" to commercial activity from Makapu'u Point to Kapoho Point and thus, the passing of Bill 38. Their voices are still echoing in our ears.

With the introduction of Bill 19 (2023), it seems that the voices of both Kailua and Waimanalo community members have faded...their efforts forgotten...their commitment to preserving our beaches, our parks and our community disregarded.

This one-size-fits-all approach for all Oʻahu public parks is not the way to handle this situation. Each park and each community has a story to tell; a history to preserve; and various needs and concerns. Most importantly, each park and community has their own limits on ACCESS and CAPACITY. From an administrative/bureaucratic standpoint, it might seem "cleaner" or more streamlined to revise this ordinance and make it fit for all Oʻahu parks. However, from a community standpoint, this approach negates the needs, concerns and desires of each community and seems to hand over permitting decisions solely to the Director of the DPR. Yes, revisions to the various sections of this ordinance are necessary, as the current ordinance and its sections do not read well and are confusing. However, eliminating Section 10-1.2 (h) and (i) from the ordinance would be destructive. For many of us, it brings peace of mind–as well as hard copy evidence that can be referred to–that commercial activity in these specific parks is prohibited.<sup>1</sup>

The Council and the Director of DPR have unfinished business pertaining to Kailua and Waimanalo. I would like to remind the Council and Director Thielen of a 2019 report entitled *Socioeconomic Impacts of Tourism in Kailua and Waimanalo, Hawai'i* (https://seagrant.soest.hawaii.edu/wp-content/uploads/2020/12/SocioEcon-FINAL-report.pdf). Funding for this project was provided by the City and County of Honolulu and the Office of Climate Change, Sustainability and Resiliency. The study itself was designed to determine the social, economic, and natural resource visitor impacts on Windward Oʻahu. The report surveyed both Kailua and Waimanalo residents, as well as visitors to Kailua and Waimanalo. With Bill 19 (2023), the *potential* for the Director of DPR to allow for commercial activity at Kailua and Kalama Beach Park, as well as beach parks between Makapuʻu and Kapoho, would compound the problem of tourism and its negative impacts on these communities.

There is zero enforcement of the current laws regarding commercial activity...I doubt there would be any enforcement of a permitting system should Bill 19 pass. Vendors who choose not to seek permits won't and will operate illegally.

The results of this 2019 report revealed widespread concern about tourism among the residents of both communities. In the case of each resident survey, over 65% of respondents agreed or strongly agreed that:

- "tourism has increased traffic,"
- "tourism has increased the cost of living,"
- "tourism has destroyed the small town feel" of the city
- "vacation rentals have reduced the availability of housing for locals,"
- "tourism has made transportation more difficult for locals,"
- "government decisions on tourism issues tend to favor tourists over locals."

Again, allowing commercial activities to take place at these parks would exacerbate the above mentioned impacts. When is *enough*, *enough*?

The February 2023 tourism statistics from the DEBEDT<sup>2</sup> state that, ..." a total of 753,750 visitors arrived in the Hawaiian Islands in February 2023, an increase of 19.5 percent from February 2022. When compared to 2019, the benchmark year prior to the COVID-19 pandemic, this represents a 96.5 percent recovery in total visitor arrivals from February 2019."

The 2019 Socioeconomic Impacts of Tourism in Kailua and Waimanalo, Hawai'i report does recommend the consideration of the following top priorities:

- "negative effects of tourism on the overall quality of life"
- "effective leadership to solve problems caused by tourism"

It is my hope that City Council will utilize its effective leadership to help our community solve these problems of commercialization/tourism. Passing Bill 19 (2023) does not solve the problem, but simply adds to it. Redacting the no commercial activity policy at public parks that fought so hard to end commercial activities is unsettling and sends a clear message to our communities that our concerns, needs and desires for protecting our parks are irrelevant. Using this report as a guide, the Director of DPR should consider current and future impacts of tourism and commercial activity on our beach parks. Kailua and Waimanalo are destinations for tourists and the capacity for these two areas is already threatened.

Passing Bill 19 (2023) is a slap in the face to the residents of Kailua, Waimanalo and other communities where commercial activity is restricted or completely prohibited. The one-size-fits-all approach is inappropriate. What is a good fit for beach parks in Waikiki is not a good fit for beach parks in Kailua.
