Your Committee on Planning and the Economy, to which was referred Bill 10 (2022), CD1, entitled:

"A BILL FOR AN ORDINANCE RELATING TO USE REGULATIONS."

The purpose of Bill 10 (2022), CD1, is to address the regulation of land uses throughout Chapter 21, Revised Ordinances of Honolulu 2021 (the "Land Use Ordinance").

Your Committee notes that the current deadline for Council action on Bill 10 (2022), CD1 is May 27, 2023. Your Committee considered a 250-day extension of this deadline requested by the Department of Planning and Permitting ("DPP") by Departmental Communication 280 (2023).

At your Committee's meeting on May 4, 2023, the DPP Director testified in support of the extension of time.

Your Committee received no oral testimony on the extension of time.
