SUBJECT: Resolution to Transfer Funds for P25 Public Safety Radio Equipment

Submitted for your consideration is a resolution to authorize the transfer of funds from the Department of Emergency Management (DEM) Fiscal Year 2023, current expense character of expenditure to DEM equipment character of expenditure.

This resolution is a requirement of Section 2-17.2(c)(2) of the Revised Ordinances of Honolulu (ROH), which requires that the Council approve by resolution any transfer of funds between characters of expenditure within the same activity whenever the cumulative amount of transfers from or to a character of expenditure exceeds the lesser of (a) \$100,000, or (b) the greater of (i) 10 percent of the appropriation for either the originating or receiving character of expenditure, or (ii) \$10,000.

This resolution will authorize the transfer of \$17,996.85 in current expense funds to equipment funds to cover the cost of replacing outdated and "end of service life" P25 public safety radio equipment used to communicate with and amongst first responders during potential and actual human-caused or natural disasters.
