FOR ACTION

 <u>BILL 32 (2023), CD1</u> – RELATING TO PUBLIC TRANSIT. Amending Chapter 15B, Revised Ordinances of Honolulu 2021 ("Public Transit") to incorporate rail service, update general provisions, and repeal outdated provisions. (Bill passed second reading and public hearing held on May 17, 2023)

PROPOSED CD2 TO BILL 32 (2023), CD1 (Submitted by Councilmember Dos Santos-Tam) – The Proposed CD2 (OCS2023-0449/5/17/2023 1:04 PM) makes the following amendments:

- A. IN SECTION 3 of the bill:
 - 1. Amends new § 15B-3.1(b)(9)(C) to add the propelling of mucus as a prohibited conduct.
 - 2. Amends new § 15B-3.1(b)(1) and § 15B-3.1(f)(2)(B)(i) to clarify that pets (as opposed to service animals and police dogs) must be kept in an enclosed and secured container.
- B. Makes miscellaneous technical and non-substantive amendments.
- BILL 20 (2023), CD1 RELATING TO PARKING. The purpose of this ordinance is to address parking in the City and County of Honolulu, including the City's restricted parking zone program. (Bill passed second reading and public hearing held on 4/19/23)

PROPOSED CD2 TO BILL 20 (2023), CD1 (Submitted by Councilmember Dos Santos-Tam) – The Proposed CD2 (OCS2023-0429/5/16/2023 3:43 PM) makes the following amendments:

- A. In SECTION 6 of the bill, removes the requirement that any expansion, reduction, modification, or dissolution of a previously-established RPZ be processed in accordance with the terms of ROH Article 13 as it read immediately prior to the effective date of the bill.
- B. In SECTION 6 of the bill, clarifies that the director may establish, reduce, modify, or dissolve an RPZ (including existing RPZ) by updating Schedule XXXIX.

- C. In SECTION 8 of the bill, limits each eligible dwelling unit to a combination of four total annual residential permits and annual visitor permits, with a maximum of one annual visitor permit per resident, plus no more than 10 single day visitor permits per month (instead of per year).
- D. In SECTION 9 of the bill, lowers the base rate for the first vehicle from \$80 to \$50 and increases the fee factor for each additional vehicle per eligible dwelling unit.
- E. In SECTION 9 of the bill, provides that the director may allot no more than 50 percent of the fees collected in an RPZ to credit city payment cards to those residents of eligible dwelling units who opt not to purchase an RPT permit.
- F. Makes miscellaneous technical and nonsubstantive amendments.
