WHEREAS, Section 6-1005, Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended ("Charter"), establishes a Fire Commission ("Commission") consisting of seven members; and

WHEREAS, Charter Section 6-1006 sets forth the powers, duties, and functions of the Commission; and

WHEREAS, pursuant to Charter Section 13-103, the members of the Commission are appointed by the Mayor and confirmed by the City Council ("Council") and serve for staggered five-year terms; and

WHEREAS, by Mayor's Message 68 (2023), dated April 3, 2023, the Mayor has appointed Ms. Debbi Eleneki to the Commission; and

WHEREAS, if confirmed by the Council, Ms. Eleneki will fill the vacancy created by the passing of Mr. Nicholas Teves, Jr., and serve for the remainder of Mr. Teves' term that expires on December 31, 2024; and

WHEREAS, Charter Section 13-103, which applies to the Commission, requires that appointees to the Commission be registered voters of the City; and

WHEREAS, the Council has reviewed Ms. Eleneki's qualifications and character and finds that Ms. Eleneki is qualified to serve on the Commission and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the appointment of Ms. Debbi Eleneki to the Fire Commission for a term expiring on December 31, 2024; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Ms. Eleneki for her willingness to be considered for public service and actively participate in city government; and
