I am writing in strong support of Bill 28, which would require commercial establishments that sell alcoholic beverages to carry a supply of naloxone to help reverse potentially fatal overdoses.

It was most welcome to see Councilmember Dos Santos Tam on Hawaii News Now relay the risks that come with the use of any opioid, including prescription opioids, with alcohol. The mixture can result in respiratory depression that can result in death.

Its salutary that some downtown businesses have already obtained naloxone—and trained their staff to use such should it be necessary. The state Department of Health has taken a proactive posture with respect to making nasal naloxone (Narcan) available at no cost to any resident upon request.

Hopefully the Council will engage in constructive conversations with state government officials to dedicate some level of funding from the opioid settlement to continue the broad provision of naloxone on Oahu, including those businesses that would be impacted by this bill.

Aloha Chair Matt Weyer and members of the committee,

I am testifying in strong support of Bill 28 (2023), "Relating to Naloxone," which would require certain establishments with liquor licenses carry doses of Naloxone.

Hawaii's opioid crisis worsening. The Hawaii State Department of Health counted there were at least 220 deadly drug overdoses last year in Hawaii. State epidemiologists believe this number will rise to 300 in 2023.

If we are going to reverse this trend, we need to make Naloxone easily accessibly - particularly in high-risk locations. As the Hawai'i State House Representative for District 24-Waikiki and Moi'iili, I represent a number of high-risk locations - particularly nightclubs and bars.

Bill 28 helps ensure that the business owners in my district are prepared for accidental overdoses. It will also reduce the number of fatal overdoses overall. This is something we need to do. I thank the Honolulu City Council for taking on this important issue.

Hawai'i Public Health Institute ⁱ (HIPHI) respectfully submits testimony in **support** of Bill 28 Relating to Naloxone. This measure would require that certain classes, kinds, and categories of liquor-licensed establishments maintain a specified amount of naloxone on their premises; and that managers be trained in the proper administration of naloxone.

This policy is an important one that will help to address the increasing deaths from opiods in our communities. We ask you to consider amending the bill to expand the parameters of thhose who would be trained in the administration of naloxone to include any "appropriate personnel" in addition to "manager" for those who would receive training. The more who are trained and gain knowledge of overdoses and the appropriate response will increase the success of the policy. Furthermore, it should be clear that no one will be held liable for providing or adminstering this life saving medicine. It is only effective if used; therefore, we want to ensure there are no barriers to that use.

Naloxone is a highly effective opiod receptor antagonist, which can counter the effects of an overdose when administered immediately. The life-saving effect of this medicine has saved people's lives. It is so effective and safe that the FDA has approved it for over the counter sales.

Thank you for considering our testimony this measure that supports public health.
