RESOLUTION

RELATING TO THE TRANSFER OF FUNDS.

WHEREAS, Section 2-17.2(c)(1), Revised Ordinances of Honolulu 2021 ("ROH"), requires that the City Council ("Council") approve by resolution any transfer of funds between activities whenever the cumulative amount of transfers from or to an activity totals in excess of \$100,000 or 10 percent of the amount appropriated for that activity in the executive operating budget ordinance, as may be amended, whichever is less; and

WHEREAS, the Honolulu Police Department is requesting a transfer of \$4,840,000 between activities from the Administrative Services (salaries ["S"] character of expenditure) to Patrol and Investigations (S character of expenditure) for the fiscal year 2023 is required to cover salary shortages; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that \$4,840,000 in General Fund ("GN") monies be transferred between the following activities:
