WHEREAS, through a letter dated May 25, 2023, the Managing Director has submitted a request to the Council for acceptance of a gift to the City from the Bloomberg Harvard City Leadership Initiative of tuition, transportation, meals and lodging with an estimated value of \$15,350 for Deputy Managing Director Krishna Jayaram to participate in the Harvard Kennedy School program, "Implementing Public Policy" in Cambridge, Massachusetts from June 10-16, 2023; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,
