Note: Prior to the start of the meeting, the Chair announced that Resolution 23-46, confirming the reappointment of Mr. Dennis Morton to serve on the Fire Commission of the City and County of Honolulu posted on the Council agenda was cancelled and would not be considered.

Chair Waters noted that Resolution 23-46 has been cancelled based on a letter from the Mayor dated May 16, Mayor's Message 99 withdrawing the appointment of Dennis Morton to the Fire Commission. Chair Waters called upon Managing Director Formby to explain.

In response to councilmembers, Mike Formby, Managing Director stated that:

- The Mayor apologizes how the situation was handled and the last minute withdrawal.
- He does not defend the process and stated that this was a mistake that he would rectify so that it does not happen again. He stated that the Mayor would like the opportunity to meet with Mr. Morton.
- The Mayor would like to appoint new commissioners for all the boards and commissions. He stated that the Mayor wants to be more deliberative and have the opportunity to go through a thoughtful reappointment or appointment process.

 The Mayor typically would call the nominee up to talk about their experiences and plans going forward. He simply would like to know if the nominee is committed to the best interests of the City. The Mayor also has the ability to review recommendations and decide who he wants to appoint and reappoint.

In response to Chair Waters, Duane Pang, Corporation Counsel stated that:

- The matter is no longer on the agenda and it is highly unusual for the Managing Director to speak upon an agenda item that has been taken off the calendar.
- The Charter requires the board member to remain on the commission until their replacement is confirmed.
