Dear Chair Waters and members of the Honolulu City Council,

It was an honor to stand next to you at the Capitol on May 9, as city and state leaders joined forces to hold the Navy accountable for poisoning our aquifer. I enthusiastically support City Council Resolution No. 23-70: URGING THE U.S. NAVY AND DEPARTMENT OF DEFENSE TO IMMEDIATELY IMPLEMENT WEEKLY TESTING OF NAVY RED HILL MONITORING WELLS AND THE RED HILL SHAFT FOR PER- AND POLYFLUOROALKYL SUBSTANCES ("PFAS") AND RELEASE THE INFORMATION REQUESTED BY THE HONOLULU BOARD OF WATER SUPPLY IN ITS LETTER TO THE U.S. SECRETARY OF DEFENSE DATED JANUARY 10, 2023.

Over the years, the Red Hill Bulk Fuel Storage Facility has been plagued with recurring mishaps. Most recently in November 2022, approximately 1,300 gallons of aqueous film forming foam (AFFF) concentrate liquid was leaked from a fire suppression system at the facility into the environment, which caused the potential release of per- and polyfluoroalkyl substances (PFAS) into our groundwater. As defined in the resolution, PFAS are known as "forever chemicals" since they break down very slowly. They can continue to pollute the environment for thousands of years, which threatens our well being and quality of life.

It is extremely disappointing to witness the Navy's lack of urgency and willingness to respond to these catastrophic events, that they created. This was not a natural disaster; this was a military disaster. Calls for transparency, action, and accountability have been met with delays and half-truths.

In February 2023, I along with other members of the Hawaii State Senate sent a joint letter urging the EPA, Navy and DLA to revise its proposed consent order to include mitigation efforts in response to the recent releases of AFFF concentrate liquid containing PFAS. More recently, the Hawaii State Legislature passed <u>House Concurrent Resolution 103</u>, which urges all branches of the United States Military operating in Hawaii to implement changes in their policies to reduce, the use of products containing PFAS.

Inaction will be detrimental to everyone's health. The Navy's practice of delaying testing and releasing data, puts Oahu's drinking water resources at risk. The Board of Water Supply needs this vital information to immediately address potential threats to our aquifer.

I strongly urge you to vote in favor of City Council Resolution No. 23-70, which is an important step in holding the Navy accountable. Thank you for your consideration.

Navy and the Department of Defense to implement weekly testing of the Navy Red Hill monitoring wells and the Red Hill Shaft for "PFAS". It goes without saying, there is a sincere concern that everything is not being done to prevent future leaks and to immediately address leaks that may occur in the future. Weekly monitoring will help to insure accountability. In the bigger picture, the responsibility of useable drinking water from all our wells and our ground water affects everyone in our island community. We should all be thinking of ways to have a greener impact on our aina, more green spaces and less concrete!

In conjunction with the testing, it is imperative that the information requested by the Honolulu BWS in their letter dated January 10, 2023 to the U. S. Secretary of Defense be release to the public. Although the Navy has made good progress in addressing the concerns of those effected by the Red Hill tank leaks and the decommissioning of the fuel tanks themselves, this information should be released to continue to build trust with full transparency. This is a volatile situation and there has been much dialogue to finding the best way forward. Full transparency is part of the democratic process and will hopefully lead to more community involvement in caring for our environment.

Each of you represent your constituents and together make decisions in the best interest of the City and County of Honolulu, all of O`ahu. Long range efforts must be made throughout the island to have drinkable water wells so that no one area or district bears the "burden" of our limited water resource. We must always be mindful to conserve water.
