WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy allows for the acceptance of gifts by the affirmative action of the Council; and

WHEREAS, through a letter dated May 18, 2023 (Mayor's Message 102 (2023)), the Managing Director has submitted a request to the Council for acceptance of a gift to the City from the Fuzhou Municipal People's Government of air and ground transportation, and hotel accommodations, valued at \$3,500, for Chief of Staff Samuel Moku to attend "Bond with Kuliang: 2023 China-U.S. People-to-People Friendship Forum" in Fuzhou, China, June 27-29, 2023; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift form attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body gratefully accepts the gift valued at \$3,500 from the Fuzhou Municipal People's Government that is more fully described in the above-referenced letter dated May 18, 2023, and the Declaration of Gift form attached as Exhibit A; and
