SUBJECT: Requested Data of the July 25, 2023 Budget Committee Meeting

The Department of Planning and Permitting (DPP) has prepared the following response for a question posed during the July 25, 2023 Budget Committee hearing.

During the discussion of Bill 39 (2023), Budget Chair Cordero asked for the allowed underlying zoning of convenience centers, wastewater treatment centers, power plants, or similar type facilities.

If the facilities are public, they are considered public uses and structures for purposes of the Land Use Ordinance (LUO), Chapter 21, Revised Ordinances of Honolulu. Public uses and structures are permitted principal uses in all zoning districts. If they are privately run, the land uses would be:
