RESOLUTION

CONFIRMING THE REAPPOINTMENT OF MR. VINCE OTSUKA TO SERVE ON THE BOARD OF REVIEW III FOR REAL PROPERTY TAX APPEALS OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 8-12.6, Revised Ordinances of Honolulu 2021 ("ROH"), establishes boards of review for real property tax appeals, each composed of five members, under the Department of Budget and Fiscal Services; and

WHEREAS, there are currently three real property tax boards of appeal; and

WHEREAS, ROH Section 8-12.7 charges a board of review with the duty of hearing and deciding real property tax appeals; and

WHEREAS, pursuant to Section 13-103 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended ("Charter"), the members of the boards of review are appointed by the Mayor and confirmed by the City Council ("Council") and serve for staggered five-year terms; and

WHEREAS, by Mayor's Message 198 (2023), dated September 7, 2023, the Mayor has reappointed Mr. Vince Otsuka to the Board of Review III; and

WHEREAS, if confirmed by the Council, Mr. Otsuka will serve for a second term to expire on June 30, 2028; and

WHEREAS, to qualify for service on a Board of Review, a nominee must comply with two requirements:

1. ROH Section 8-12.6 requires a member to have resided in the State of Hawai'i for at least three years at the time of the appointment; and
2. Charter Section 13-103 requires a member to be a registered voter of the City and County of Honolulu; and

WHEREAS, the Council has reviewed Mr. Otsuka's qualifications and character and finds that he is qualified to serve on the Board of Review III and deserves confirmation; now, therefore,
