Your Committee on Executive Management, which considered Resolution 23-278 entitled:

“RESOLUTION RELATING TO THE APPOINTMENT OF THE DIRECTOR OF THE OFFICE OF COUNCIL SERVICES,”

introduced on November 7, 2023, reports as follows:

The purpose of this Resolution is to concur with the recommendation of the Selection Advisory Committee as shown in Council Communication 285 (2023) and hereby appoint Mr. Wintehn Park to serve as the Director of the Office of Council Services for a six-year term commencing on December 7, 2023, at a salary of \$187,488 per year; and at its discretion, may periodically evaluate the performance of the Director of the Office of Council Services.

Mr. Park provided a brief introduction about himself and expressed his willingness to serve as the Director of the Office of Council Services, and responded to questions from members.

At your Committee's meeting on November 14, 2023, one individual testified in support of the Resolution.

Your Committee received written testimony in support from 25 individuals and CARES.
