WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended, provides the City Council ("Council") with authority to accept gifts to the City and County of Honolulu ("City"); and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy provides for the acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated December 5, 2023, approved by the Managing Director, the Chief of Police of the Honolulu Police Department (HPD) has submitted a request to the Council for acceptance of a gift to the City from The Deputies of a new ASUS laptop, IDCore software, Data Card ID3 Sigma double-sided printer, MS LifeCam Studio webcam, Pelican hard case, five 4-color ribbons, and printer maintenance valued at \$6,926.42 for the HPD's Law Enforcement Explorer Program; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body gratefully accepts the gift valued at \$6,926.42 from The Deputies that is more fully described in the above-mentioned letter dated December 5, 2023, and the Declaration of Gift attached as Exhibit A; and
