Aloha Hawaii State Legislature Ohana:

Having recently retired here on Maui to my "home-state" of Hawaii after serving as a Federal Employee for many years on the mainland, I decided to "re-activate" my performance union status in SAG-AFTRA to see about getting some work here in my Senior years. However, between the Maui wildfire disaster and lack of any outer-island film & tv opportunities, I have been frustrated at the lack of opportunities for any kind of acting employment

Maui is currently in dire need of local business diversification due to the impact of the wildfires on the local tourist economy. Our tourist arrivals were only 25% of the previous year over the recent holiday season, and the impact on every aspect of our local economy (almost entirely dependent on tourist- related businesses), and Maui is at this point NOT a sought-after location for the film & tv industries. The cost of living in our state is astronomical, and the overhead for production priced out of contention by

much cheaper 'tropical' locations like Puerto Rico and the Dominican Republic.

I lived and worked in Atlanta for 5 years, and the economic boom engendered by the generous film-industry tax incentives in that state were unbelievable. With our state currently experiencing a decline in tourism overall, and Maui in particular having a negative apeal to visitors from the fires, ANYTHING we as state residents can do to re-habilitate Hawaii's image as a supreme, world-class destination unique in culture, beauty, and the aloha spirit could have a huge impact on Maui's recovery and a healthy diversification of industry NOT tied directly to tourism.

Filming generates jobs on so many levels; not just for actor's performers, but construction, technical jobs, catering, temporary housing, transportation, etc. etc. etc. Hawaii has a record of successfully producing film industry product, but at this point with the general perception that our state's cost ratio is astronomical compared to other tropical destinations, incentivizing film production through a robust tax restructuring can only benefit our state in positive and economically ramifications statewide.

# Testimony in Support for Bill 59 **RELATING TO INCENTIVES FOR FILM STUDIO FACILITIES.**

Chair Waters, Vice Chair Kiaāina, and Members of the City Council,

I write today as a private citizen in strong support and with appreciation for Bill 59, which would help to enhance our successful film, television and streaming content production industry.

In 2022, according to DBEDT, the production industry had a qualifed direct spend of \$483 million dollars across the state – the vast majority of that being spent in the City and County of Honolulu. Much of that is in the form of living wage jobs for local workers, with DBEDT also reporting that film and television union crews average over 80% residents. According to the Producer of NBCs *Magnum PI*, their cast and crew were 89% local Honolulu residents.

State tax production incentives have been an essential driver of this economic diversification, starting with Act 88 in 2006. Before Act 88, Hawaii never saw more than \$100 million in production per year. Since then, our industry has climbed to a DBEDT reported average of \$396 million dollars in direct spend per annum.

But Hawaii, and especially Oahu with 75 to 90% of annual production spend, is missing out on potentially hundreds of millions of dollars because of our lack of production infrastructure. Currently, the State runs the single stage Diamond Head Studio and the World War 2 era hangers/make shift stages at Kalaeloa – both are occupied by CBSs *NCIS* television series. There is no industry standard studio complex which can accomodate multiple series or large motion pictures in the islands.

So, huge productions and franchises like *Jumanji*, *Jurrassic Park*, *Pirates of the Caribbean*, *Midway*, and *Godzilla* are only able to shoot their location footage here and then move to Los Angeles, Georgia, Montreal, and London where they can access the massive sound stages and post production facilities we do not have here. This move is expensive for them and a huge loss of revenue for us as stage and visual effects work make up the majority of the budget of the typical blockbuster movie.

Even stories about Hawaii or Hawaii adjacent have to go elsewhere to complete the bulk of their \$100 million+ shoots. For example, Apple TVs *Chief of War*, starring Jason Momoa, which is about our island history, is reported to have shot 30 days here in

Hawaii, but 150 days in New Zealand. Disneys upcoming live action version of *Moana*, starring Dwayne Johnson, will shoot briefly on location here, but then move everything to Atlanta to access their studio facilities.

With Bill 59, the City and County of Honolulu has the opportunity to help stop this leakage of economic activity and keep production here in Hawaii.

#### BILL 59 – RELATED TO INCENTIVES FOR FILM STUDIO FACILITIES

Chair Waters, Vice Chair Kia'āina, and Members of the City Council:

My name is Sumner La Croix, and I am Professor Emeritus in the UH-Mānoa Economics Dept and a Senior Research Fellow at the University of Hawai'i Economic Research Organization (UHERO). I am testifying today in a private capacity and my views do not necessarily reflect those of UH-Mānoa or UHERO.

Professor Emeritus James Mak and I have previously written on the role of the Hawai'i TV/film/digital production tax credit in diversifying the Hawai'i economy. See <a href="https://uhero.hawaii.edu/understanding-the-role-of-the-hawaii-film-tv-digital-production-tax-credit-in-diversifying-the-hawaii-economy/">https://uhero.hawaii.edu/understanding-the-role-of-the-hawaii-film-tv-digital-production-tax-credit-in-diversifying-the-hawaii-economy/</a>. The State of Hawai'i is one of more than 30 states to offer a tax credit to film, TV, and digital productions (hereafter "film credit"). Since the passage of the film credit in 2006, spending in Hawaii on TV/film productions has soared, with inflation-adjusted spending increasing by 116 percent between 2007 (\$164.5 million) and 2019 (\$355.6 million). This is much larger than the overall increase in Hawaii real gross domestic product over the same period, a modest 17 percent.

Why does a production company choose Hawaii as the location to film its project when costs of labor and rented capital are lower in many other locations? The main reason is the access the company gains to natural and cultural capital—Hawai'i's diverse natural landscapes, warm weather with trade winds, the unique urban landscapes of the tropical city of Honolulu, and the mix of people from diverse cultural backgrounds. A production company will also consider the net of tax credit cost of filming a project in Hawaii vis-à-vis another location.

There is more to building a robust film industry in Hawai'i than a competitive film tax credit. Two other factors that attract film/TV productions to Hawai'i are (1) availability of workers with skills valued by the industry and (2) availability of state-of-the-art production studios.

Expanded undergraduate education programs and facilities dedicated to film/TV/digital production at many UH campuses are providing college students with skills and overall knowledge valued by film/TV/digital production companies. The new UH-West Oahu facilities have the potential to make UH's Academy for Creative media one of the leading schools for content production in the United States. The Academy's expansion will make it easier for content production companies filming in Hawaii to staff jobs in their productions with local talent, while other UH program graduates will be encouraged to start their own companies. Learning-by-doing for the many workers involved in the long-running *Hawaii 5-0, Magnum PI* and *NCIS: Hawai'i* TV series has made them more skilled, more experienced, and more valuable employees. The combination of skilled, experienced local talent and fresh graduates from the Academy for Creative Media will serve as a magnet for production companies to choose Hawai'i for future ventures.

Private investment in a film studio(s) for use by Hawai'i and overseas production companies has potential to attract more film/TV projects to Hawai'i. In general, U.S. states with thriving film industries are ones where substantial <u>public and private</u> capital investments in production studios and ancillary facilities have taken place. Private investors have, however, not made substantial investments in facilities for the film/TV industry in Hawai'i. Both existing studios are fully occupied with ongoing productions filming in Hawai'i. However, an adjacent site on Farrington Highway near the new UH-West Oahu facilities has been identified as a potential site for a private production studio to be developed with private funding on UH land. In Fall 2023 UH solicited bids from film studio companies to develop the property, and is in the process of evaluating them in January 2024.

A new privately-built and privately-operated film studio would bring economic benefits to Hawai'i and, more specifically, to Honolulu residents.

- <u>New Jobs</u>. A new studio <u>would</u> create new construction jobs while it is being built; create new professional jobs in West Oahu when it begins operating; and create "spillover" jobs in the surrounding community via the spending by studio employees and the studio company at Honolulu and Hawai'i businesses.
- Additional Enrollment at UH-West Oahu Campus. The presence of a film studio adjacent to the Academy for Creative Media's new facilities would raise the value to students of attending the Academy and elevate the Academy's reputation. This would attract new out-of-state and in-state tuition-paying students to UH-West Oahu and allow the campus both to increase its tuition revenues and to operate more efficiently.
- New State and County-City Tax Revenues. The new economic activity generated by a new film studio would yield additional property tax revenues for Honolulu on the studio structures, additional GET revenues for Honolulu and the State of Hawaii, and additional income tax revenues for the State of Hawaii.

Property Tax Waiver on Studio Land. Is it necessary for the City and County of Honolulu to waive property taxes on the land used by the new film studio to attract it to locate in Honolulu? The bottom line is that no production facility of this size is built in the United States today without significant tax credits being awarded by a state or local government. While there are significant natural and cultural benefits to a studio from locating in Honolulu, other USA and international cities can also offer substantial natural and cultural benefits to a studio locating in that city. A waiver of property taxes by the City and County of Honolulu would help to attract a new studio to Honolulu which would, in turn generate new economic activity benefitting Honolulu residents.

The UH land surrounding UH West Oahu does not currently generate tax revenue and there are no other businesses currently willing to invest in the neighborhood of \$100 million in this property. Thus, awarding a waiver of property taxes to a large new studio development would not entail a loss of tax revenue for the City and County of Honolulu. Housing is a potential alternative use of this parcel, but there is considerable UH acreage near the UH West Oahu campus and the Skyline transit station (Keone'ae) that could be utilized for new housing.

My name is Kiran Polk, and I am the Executive Director of the Kapolei Chamber of Commerce. The Kapolei Chamber is an advocate for businesses in the Kapolei region which includes Waipahu to Ka'ena Point. The Chamber works on behalf of its members and the entire business community to improve the regional and state economic climate and help Kapolei businesses thrive. We are a member- driven, member-supported organization representing the interests of all types of business: small, medium or large, for profit or non-profit businesses or sole proprietorship.

The Kapolei Chamber is in **support** of Bill 59 (2023) which would provide real property tax incentives for the dedication of real property for eligible film studio facilities.

The Kapolei Chamber of Commerce has prioritized the effort to support the establishment of a film studio in West O'ahu. One of the priorities of the Business Revitalization Task Force is to "Advocate for job growth in digital media, film production and technology industries in West O'ahu."

This measure will provide the needed incentives to grow a billion-dollar industry here in Hawai'i.

According to the Motion Picture Association, the film and television industry is directly responsible for more than 3,630 jobs in the Islands, which includes more than \$192 million in wages statewide. Hawai'i's Motion Picture, Digital Media and Film Production Income Tax Credit production reports data indicates that local hires are at 80% on average, if not higher.

A film studio would only bring revenue into O'ahu county, it will provide an opportunity for our students to stay here in Hawai'i making a living wage and provide an opportunity for Hawai'i residents to return home. There are opportunities to employ Hawai'i people across a range of sectors, from construction, catering, costuming, camera, post-production, and beyond. We also believe that West O'ahu provides the ideal location for a film studio, with the University of Hawai'i – West O'ahu's Academy of Creative Media establishing just a couple of years ago. The measure also supports providing internships for our future workforce which is also essential to grow this industry.

More jobs, specifically living wage, professional jobs are needed on the west side to keep pace with the population growth in West O'ahu. Decades ago, the City and County of Honolulu adopted a goal of creating a "Second City" and moving residential and economic growth toward West O'ahu. West O'ahu's growing population of almost 200,000 includes the Wai'anae Coast, 'Ewa, and Waipahu. In Kapolei and 'Ewa alone households are expected to exceed 56,000 by the year 2035 and over the next 30 years the population in Kapolei and 'Ewa will increase by 40 percent and housing by 52 percent.

We believe the incentives for job growth, especially in West O`ahu are warranted and needed. We also specifically support job growth in film production on the west side including the incentives so greatly needed to support the effort.

I believe this will bring Hawaii more production work, help us RETAIN more productions for the full arch or most all of the production life-cycle and help us diversify our economy. We need large, state of the art studio facilities here to compete, capture and maintain large productions for long term (rather than having productions do piece meal shoots here, then go to other states or countries to utilize their state of the art, large format studios, to complete the rest of their production.)

- Provides economic diversification that will increase our resilience.
- Has wider economic impact than merely that of the dollars spent on the set/production by engaging many other auxiliary industries and vendors

Aloha Chair Cordero and Members of the Committee,

MAHALO for the opportunity to provide testimony in <u>SUPPORT of BILL 59</u>. The IATSE is the largest entertainment union in the world, and Local 665 represents nearly 800 members and 700 trainees who work behind the scenes in film, television, live events and tradeshows across the Hawaiian Islands.

Bill 59 would incentivize the construction of a full-fledged film studio on O'ahu. This would make Hawai'i more competitive with other film locales, diversify and grow our economy, create small businesses and bring <u>new</u> revenue to the City and County.

"NCIS – Hawai'i" is a large television series and has occupied the Diamond Head Studio (DHS) for the past two years where they are limited to three stages. When "Magnum P.I." was canceled last year, "NCIS- Hawai'i" took over the Kalaeloa Stages, indicating their need for more space. The Kalaeloa Stages were vacant military buildings that have been retrofitted into film stages, but they lack soundproofing and stage space that a proper film studio would provide.

For the past 20 years, the Diamond Head Studio has had a reliable tenant every year, bringing consistent revenue to the State. From 2004 – 2010, the ABC TV series, "Lost" was based there, then CBS's reboot of "Hawai'i Five-O" and "Magnum P.I." moved in, and it is now home to "NCIS – Hawai'i." It seems that once a major studio occupies the DHS, they try very hard to keep it occupied, and I foresee that happening to the new film studio as well. "If you build it, they will come."

In 2021, a huge town of exterior facades were built for a movie, but the company built interior sets on stages on the mainland and shot there for several months after leaving Hawai'i. Had we interior stage space for them to use, there would have been more local film workers hired to build the sets, and the company would have extended their stay by several months, equating to more money spent in the county and state.

The longer a show stays here, the more predictable income becomes and <u>the more stable families become</u>. A long-running television series is as close to full-time employment as one can get in the film industry, lasting as long as nine months out of the year. Multiple concurrent television shows as we have enjoyed recently are ideal for training and growth.



Television series love filming our beautiful scenery and landscapes and need interior stage space to film on rainy days, when locations cannot accommodate the size of the company or the interior location is unsuitable.

In mainland cities where stages have been built, a microcosm of ancillary businesses is often created. For instance, in Atlanta, GA, a hardware store, hotel, eateries, grocery stores and other businesses were built to accommodate the growing film community. We can expect, and should plan for, similar growth near our new film studio.

Of course, the Building Trades Union workers would benefit by constructing the facility.

#### The economic impact by the film industry is compelling:

- employs several hundred Hawai'i members and residents per show.
- sustains thousands of creative sector jobs
- provides millions of dollars in economic impact for the state.
- In 2021, the industry spent \$421 million in estimated production expenditures, generated an estimated \$728 million of economic impact, \$45.5 million in estimated tax revenues, and total job impacts of 4180 jobs.

There are many benefits to supporting the building of a new film studio, and the timing of this bill is critical. The State has created educational and training opportunities for the film industry at UH-Manoa and UH-West Oahu, and we need to provide jobs for these new graduates or we will be educating and training someone else's work force because they will need to go where the work is.

I support the development of studios and other infrastructure programs that support local filmmakers and the creative industries. I urge the Council to <u>SUPPORT BILL 59</u>.

# In consideration of Bill 59 (23) CD 1 A BILL RELATING TO INCENTIVES FOR FILM STUDIO FACILITIES.

Honorable Chair Waters and members of the Honolulu City Council.

The Department of Business, Economic Development & Tourism (DBEDT) and its Creative Industries Division (CID) supports Bill 59 (23), CD1, which would establish incentives to develop purpose-built facilities for film production within the City and County of Honolulu on a minimum of 10 acres at a minimum development cost of \$100,000,000.

In 2022, film production expenditures in the state reached an estimated \$420 million, with an economic impact of \$726 million, and 4,000 local jobs. Our film industry can only grow beyond this metric if new facilities are developed, and we increase our skilled workforce.

To move beyond the current talent pool and jobs this industry generates, three key components are required; 1) a reliable film production income tax credit (HRS 235-17), 2) an interconnected education pipeline and entrepreneurial training (Good Jobs HI and Good Jobs Oahu), and 3) purpose-built facilities to drive the industry growth.

The state recognizes the potential of this sector to further diversify our economy. Incentives for facilities expansion are crucial. This Legislative session, the state has introduced amendments to the Motion Picture, Digital Media, and Film Production Income Tax Credit (HRS 235-17) by adding an infrastructure credit to accelerate facilities development and expansion statewide (HB2360 and SB3049).

Vital to the industry expansion is our workforce. DBEDT's work with UH, our community sector partnerships are focused on increasing skills from curriculum to career, building a dynamic workforce in these creative sectors, providing students and residents opportunities to build careers while remaining here at home.

For these reasons, DBEDT supports Bill 59 (CD1) as it provides a foundation for infrastructure growth and with that, the talent pipeline necessary to accelerate our \$400M industry into a billion-dollar film industry for our state.
