ESTABLISHING A SISTER CITY RELATIONSHIP WITH RAROTONGA, COOK ISLANDS.

WHEREAS, Resolution 21-212 establishes guidelines for the City and County of Honolulu ("City") that governs the establishment and termination of its sister city relationships ("Guidelines"); and

WHEREAS, the Guidelines provide that a sister city relationship may be established with another city that:

- 1. Shares a direct historical, cultural, or ethnic relationship with the people of Honolulu;
- 2. Be similar in population size or character to Honolulu; and
- 3. Share common public policy goals with Honolulu, including the promotion of business, trade, and tourism or the mutual exchange of friendship, culture, education, and technology.

WHEREAS, Rarotonga, Cook Islands, is a culturally rich island with a population that shares common values and interests with the people of Honolulu; and

WHEREAS, expanded transportation between Rarotonga and Honolulu have strengthened economic ties and tourism between the two cities; and

WHEREAS, Rarotonga, Cook Islands, is committed to a sustainable and regenerative approach to tourism to ensure the preservation of its natural resources, culture, and environment; and

WHEREAS, the establishment of a sister city relationship will provide an opportunity for residents of both cities to engage in mutual exchanges by fostering understanding and cooperation that will benefit both cities by sharing best practices on the environment, economy, education, and tourism; and

WHEREAS, this relationship will highlight the importance of fostering international friendships and cultural exchanges between cities around the world; and
