WHEREAS, the Council has reviewed the qualifications and character of Mr. Robinson and finds that he qualifies to serve on the Board of Parks and Recreation and deserves confirmation for reappointment; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the reappointment of Mr. Robinson to the Board of Parks and Recreation for a term expiring on December 31, 2028; and
