RESOLUTION

CONFIRMING THE REAPPOINTMENT OF MICHAEL ROBINSON TO SERVE ON THE BOARD OF PARKS AND RECREATION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-1404, Revised Charter of the City and County of Honolulu 1973, as amended ("RCH"), establishes an advisory Board of Parks and Recreation; and

WHEREAS, the Board of Parks and Recreation consists of nine members appointed by the Mayor and confirmed by the Council to staggered five-year terms; and

WHEREAS, the major duties of the Board of Parks and Recreation are to advise the Mayor, the Council, and the Director of the Department of Parks and Recreation on matters relating to the recreational, cultural, and entertainment activities and facilities of the City and on the beautification of such facilities and public streets of the City; and

WHEREAS, by Mayor's letter, dated February 8, 2024, the Mayor has reappointed Mr. Michael Robinson to the Board of Parks and Recreation; and

WHEREAS, if confirmed by the Council, Mr. Robinson will serve for a second term to expire on December 31, 2028; and

WHEREAS, Section 13-103, RCH, which applies to the Board of Parks and Recreation, includes a general qualification requiring a member to be a registered voter of the City; and

WHEREAS, the Council has reviewed the qualifications and character of Mr. Robinson and finds that he qualifies to serve on the Board of Parks and Recreation and deserves confirmation for reappointment; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the reappointment of Mr. Robinson to the Board of Parks and Recreation for a term expiring on December 31, 2028; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Robinson for his willingness to serve the City and County of Honolulu; and
