Aloha Council Members,

I am writing in strong support of this resolution. I have been an ocean safety advocate for more than seven years ever since losing my husband and youngest daughter at the Makapu'u Tidepools in 2016 due to a massive rogue wave set from an offshore storm that they did not know about. Since then I have supported the need for more outreach and prevention efforts from Ocean Safety, and it has come to my attention that the current set up with Ocean Safety under EMS significantly limits their ability to advocate for what they need, including a more robust outreach campaign. Having a separate department would allow them to determine their own messaging and partner further on outreach initiatives. Much more could be done on the prevention side to reduce the need for so many on-site interventions and rescues. More prevention outreach would actually save money - and it would also be an investment in critical safety services in a state surrounded be water where drowning is the leading cause of death for visitors and where residents have the 2nd highest rate of drowning in the nation. Of course most of these drownings occur right here on Oahu as the island with the highest population and visitor numbers, and we have a duty to do all we can to reduce this grim data. I know our lifeguards are doing all they can in the current situation, and this shift to a full Department is critical to expanding their capacity to do more. The experts in ocean safety should determine how to best do their job of 'guarding lives.' Ocean Safety leadership should be able to speak freely in relation to their vision and needs and to determine the best use of available funds. A separate department would also allow them to innovate as leaders in our waterman culture. Our world-class lifeguards need to be supported and celebrated, and a separate Honolulu Department of Ocean Safety is the best way to do so.

As a kupuna living in Halawa District 6, I go to Ala Moana Beach Park as part of my morning routine on weekdays and appreciate the lifeguards on duty protecting the swimmers and surfers alike, while providing information and first aid to people who approach their towers.

I am writing in strong support of Resolution 24-50, INITIATING AMENDMENTS TO THE REVISED CHARTER OF THE CITY AND COUNTY OF HONOLULU 1973 (AMENDED 2017 EDITION), AS AMENDED, RELATING TO THE ESTABLISHMENT OF A DEPARTMENT OF OCEAN SAFETY. When making Ocean Safety a separate department first came up in 2021 in Resolution 21-122, I testified in support.

Locals and tourists alike flock to O`ahu beaches for fun and relaxation. The Ocean Safety and Lifeguard Services Division is the primary responder for emergencies on the beaches and in the near shore waters, including ocean rescue, prevention, emergency medical first response, dispatched mobile patrol, education, outreach, and injury prevention programs, all related to ocean safety.

The Division has been challenged with maintaining service levels by an ever-increasing amount of ocean activity. The increase in ocean and beach use over the past several decades have seen significant increases in off shore activity, particularly with the introduction of kayak rental operations, stand up paddling activities, and surf instruction operations. With climate change, the beaches and shores have become more dangerous for all beachgoers. Even unaware sightseers who endanger themselves without even getting in the water need assistance or warning from our lifeguards!

Currently, Ocean Safety is a division of the Department of Emergency Services, which serves as the City's primary provider of emergency medical care; developing and providing training and educational programs related to emergency medical services and injury prevention; being responsible for medical matters relating to public health and welfare; and being responsible for the administration of the City's health services programs and medical evaluations of current and prospective City employees. Under this set up, Ocean Safety has not had the priority and autonomy it needs to operate most effectively.

With its own director, the Department of Ocean Safety will have a strong and knowledgeable advocate with respect to its budget and operations, who can also promptly respond to the needs of Ocean Safety staff as they give their 110% every day to keep our residents and visitors safe.

I am a former Honolulu Ocean Safety Officer, former Ocean Safety Chief for Maui County, former Federal Beach Lifeguard Manager, former Ocean Safety Administrator for Oahu and Maritime Enforcement Specialist for the USCG. I am currently the Oahu Island Chief for DLNR Conservation /Marine Enforcement. I've spent my entire adult life in the public safety /lifesaving field. This is my personal view based on my professional experience for the past 38 years.

I STRONGLY support the Honolulu Ocean Safety Division becoming its own Department. It is long overdue. As a former OS Chief, one of the biggest frustrations I endured was running an agency under the oversight and purview of non-lifeguards. Most EMS personnel are amazing lifesavers and true hero's. They are amazing at what they do and they should be given all the respect and resources they deserve. However, police departments should be run by experienced law enforcement officers, fire depts. should be run by experienced firefighters and lifeguards should be run by ocean lifesavers. There is some crossover on the emergency medical side for paramedics but the job of a lifeguard has its own unique skillsets, approach and idiosyncrasies often misunderstood by those who never sat in a tower. Lifeguards are pro-active preventative public safety specialists while paramedics are primarily reactive responders to 911 calls. Sorry to be blunt, but my former leadership at EMS purchased thousands of dollars worth of swift water rescue gear (for river rescue) even though beach lifeguards don't do swift water rescue. They purchased a prop driven Whaler boat that couldn't make rescues in the surf zone or over shallow reefs like a PWC. All went unused. Wasted tax payer dollars. Just two examples of not getting it but also not having the humility to defer to the subject matter experts below them in assessing actual lifeguard needs and priorities.

Hawaii is an island state surrounded by water reliant on the ocean and beaches for its economy, culture and lifestyle. We should have the premier lifeguard agency in the world but we really don't. We have some of the best watermen /women at our disposal, but the agency still exists as the lessor priority red headed stepchild in the public safety realm and will likely remain as such if it stays under HESD. I urge you to put politics and funding apprehension aside. Do what's right for the people and visitors of Oahu and establish Ocean Safety as its own Department so that it may succeed toward becoming the best of the best. Something the Mayor and the Council can be proud of. We already have the best pool of talent. Let's move them out of converted broom closets between park bathrooms and give them the proper oversight, facilities, tools, and training they deserve. What is more important and more honorable than a clear and direct mission to save a precious human life. Why are we even debating this, it's a no brainer this is simply the Pono thing to do.

My name is Ralph Goto, I was in charge of the City and County Honolulu's Ocean Safety and Lifeguard Services Division for 32 years, from 1981 until my retirement from the City at the end of 2013. During my tenure, I was privileged to be associated with some of the finest watermen and women in the ocean safety profession, and participated in the evolution of the City and County's ocean lifeguard service into a leader in the international lifesaving community.

At the beginning of my career, Honolulu's water safety operation was a section in the Department of Parks and Recreation that comprised of approximately 30 fulltime lifeguards and 25 parttime, hourly employees with an annual operating budget of a few hundred thousand dollars. Over the years, strategies were implemented to improve training and operational standards in the division; staffing and budgets were gradually increased, albeit slowly and incrementally. I served under five mayors and ten different parks directors, some more aware of the importance of ocean safety and its connection to tourism than others.

Hawall is recognized as the surfing mecca of the world, attracting thousands to our islands to challenge the unique conditions of our ocean and surf. In the early 1990's, a group of forward thinking and skilled lifeguards began using jet skis to perform rescues in the big surf of Oahu's North Shore. Initially viewed with skepticism, the use of personal watercraft for ocean safety rescue has now become a standard for lifesaving agencies around the world. City and County Ocean Safety personnel were the pioneers in the development of the jet ski as a lifesaving tool, and countless lives have been saved as a result of their efforts. During the last two decades of my tenure, with the support from the administration, City Council, public employee union and, most importantly, the residents and citizens, City and County lifeguards began to be recognized as legitimate public safety professionals. Salaries and budgets were increased, union negotiated benefits improved, the level of training and professionalism was significant. City and County Water Safety Officers have worked for and have now begun to receive compensation and benefits commensurate with the essential lifesaving duties they perform. In 2022, the State Legislature and the Hawaii Government Employees Association (HGEA) created a new bargaining unit within the HGEA, Bargaining Unit 15, exclusively representing Water Safety and Ocean Safety Officers in the State of Hawaii.

The City and County of Honolulu's Ocean Safety Division is recognized as the largest year-round professional lifeguard operation in the world, currently employing over two hundred fifty fulltime lifeguards with an annual budget exceeding \$20 million. The division is a certified agency in the United States Lifesaving Association (USLA) and serves as a resource for training and operations for national and international lifeguard leaders seeking advice and information.

The next logical step in this developmental continuum is to amend the City Charter of Honolulu to establish a Department of Ocean Safety. Currently administered by the Honolulu Emergency Services Department, the division shares administrative support, budgets, and direction with the Emergency Medical Services Division and the Health Services Branch. Although similar in general duties (emergency medical response), the three divisions have unique missions and functional plans. A task force has been appointed and convened to research and develop recommendations regarding the establishment of a Department of Ocean Safety as one of the twenty departments as allowed in the Revised Charter of the City and County of Honolulu. Results and recommendations for the Mayor are currently being finalized and will be presented to the Mayor in the near future.

As a member of the task force and as the retired administrator of the City and County's Ocean Safety Division, I strongly and respectfully request your consideration and favorable support of Resolution 24-050. The establishment of a Department of Ocean Safety will not only improve the administrative and operational functions of our ocean lifeguard service, it will ultimately benefit the safety and well-being of the millions of visitors and residents who enjoy our ocean and beaches every year.

Thank you for the opportunity to testify on this important matter.
