RESOLUTION

CONFIRMING THE APPOINTMENT OF MARIE KUMABE TO SERVE ON THE
SALARY COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 3-122, Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended ("Charter"), establishes the Salary Commission; and

WHEREAS, the Salary Commission is responsible for establishing the salaries of elected officers of the City and County of Honolulu ("City"), the Managing Director, the Deputy Managing Director, department heads, deputy department heads, the Band Director, and the salary schedules for the deputies of the Corporation Counsel and Prosecuting Attorney; and

WHEREAS, the Salary Commission is composed of seven members, appointed to staggered five-year terms as follows:

- (1) The Mayor, without the necessity of confirmation by the City Council ("Council"), appoints three members;
- (2) The Council appoints three members; and
- (3) The Mayor appoints, subject to Council confirmation, the seventh member; and

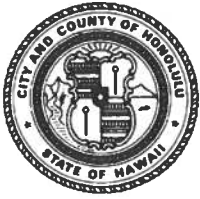
WHEREAS, by the Mayor's letter dated February 8, 2024, the Mayor has appointed Ms. Marie Kumabe to the Salary Commission to be the Mayor's appointee confirmed by the Council; and

WHEREAS, the Mayor's letter dated February 16, 2024 contains the nominee form for Ms. Kumabe's appointment to the Salary Commission; and

WHEREAS, if confirmed by the Council, Ms. Kumabe would succeed Ms. Diane Peters-Nguyen, whose term expired on January 15, 2023; and

WHEREAS, Charter Section 13-103 requires that members of City boards and commissions be duly registered voters of the City; and

WHEREAS, the Council has reviewed Ms. Kumabe's qualifications and character and finds that Ms. Kumabe qualifies to serve on the Salary Commission; now, therefore,
