#### **MAJOR CHANGES FROM FY2024 BUDGET:**

+\$393,600: Negotiated collective bargaining increases for 43 support staff positions; and salary adjustments/merit increases for 55 Deputy Corporation Counsel positions at salary levels commensurate with the expertise of the attorney candidates and at rates competitive within the legal profession. COR continues to recruit candidates with needed expertise to satisfy the City's legal workload requirements.

\$126,775: No transfer to the Provision for Vacant Positions in FY2025 to allow COR to fill vacancies.

\$(100,000): Decrease in Parts & Accessories-Equipment reflecting one-time addition in FY2024 to purchase needed office furniture and fixtures for COR's library office renovation to provide sufficient office space for authorized COR Deputy positions.
