





- The existing small generator did not power the newest 70 capacity refrigeration unit during power outages.
 - → We cannot consolidate all remains to refrigerated spaces that are on generator power.
- Reduce the number of stored remains by using an offsite body storage facility (\$17,000 x 12) until a larger generator replaces the existing small generator

Forensic pathologist shortage

- We have 5 positions for forensic pathologists.
- Two vacant positions
 - Deputy Medical Examiner Since Nov 2019
 - Forensic Pathologist
 Since Sep 2023
- Recruitment
 - Three applicants withdrew the application or turned down our job offer.
- Major causes
 - Nationwide shortage in forensic pathologists
 - Salary is competitive: High cost of living greatly reduces the value
 - Deputy: Management/supervisor job is generally not attractive
- Retention and recruitment are both critical
 - Working with DHR and Salary Commission
