\$9.9 million Grants in Aid funding supports approximately 60 nonprofit organizations. \$80.7 million federal funding provides rental assistance to approximately 4,400 households thru its Section 8, Family Unification, HUD VASH, Emergency Housing Voucher programs.

\$15.2 million state, federal and general funds supports programs and facilities that address homelessness, including Housing First vouchers, shelters, transitional housing, hygiene facilities, rehabilitation, transportation, and outreach.


\$17.3 million state and federal funds for sub-recipient grants, which provide assistance services to help 40,000 older adults remain in their homes and age in place.

\$9.8 million in federal funding is allocated to provide employment, training, and housing assistance for approximately 36,000 adults and youth residing on Oahu.
