Salary Commission 2023

- Salary Commission discussed the salary inversion problem of Deputy Medical Examiner (DME).
 - DME position has been vacant since November 2019.
 - Increase in salary recommended (\$273,024 → \$354,168)
 - FY 2024-25 salary for forensic pathologists

Recruitment for DME position

- Resumed in July 2023:
 - Increased salary amount \$354,168
 - Added relocation incentive \$20,000

DEPUTY CHIEF MEDICAL EXAMINER

\$354,168 yearly

An appointed non-civil service position responsible for assisting in the oversight of the agency and administrative tasks.

The position is considered to be part of the Mayor's cabinet.

Deputy Chief Medical Examiner Duties Include:

- Conducting approximately 100-200 autopsies per year when fully staffed
- · Managing the Department of the Medical Examiner
- · Attending Mayor's cabinet meetings
- · Participating in city-related activities
- · Working towards NAME accreditation



Position Requirements:

- · Must be a United States citizen
- Graduation from an accredited school of medicine with a degree of Doctor of Medicine or Doctor of Osteopathic Medicine, completion of an approved pathology residency training at a recognized institution
- Certification by the American Board of Pathology in Anatomic or Forensic Pathology Certification in both Anatomic and Forensic Pathology preferred
- . Current license to practice medicine in the State of Hawaii, prior to appointment
- . Desirable: Several years of experience as a practicing Forensic Pathologist

- . Toxicology testing currently provided by NMS Labs with short turnaround time

Recruitment for DME position – current FP

- Current civil service Forensic Pathologists were asked.
 - Two pathologists had already told me they were not interested.
 - Enjoyed forensic pathology work but did not like management/supervision
 - One of them was non-US citizen.
 - The newest pathologist Joined MED in March 2023
 - Had experience in management/supervision, great personality
 - He was not interested in DME.
 - "The primary reason I left (his previous workplace) was because I did not enjoy the administrative aspects and overseeing people. That's why this job has been a great fit for me at this time in my life."

Recruitment for DME position

- An applicant for DME (August 2023)
 - 5 years of experience: Shorter than our Forensic Pathologists (7-10 years)
 - As we were going to conduct an interview, the application was withdrawn.
 - "The risks of a relocation may be too great for our family."

Pathologist shortage - again


- The newest pathologist resigned in September 2023.
 - Reason: His spouse could not get a job in Honolulu, and their parents were getting older in the mainland.

Recruitment for civil service Forensic Pathologist position

- Concurrent recruitment for civil service Forensic Pathologist position
 - Compensation
 - Salary tiers \$295,000 \$325,000 based on experience and additional board certification
 - Relocation incentive \$20,000
 - Two applicants
 - One with 2 years of experience, the other still in training
 - Salary set as \$295,000
 - Added bonus \$10,740 (after completion of each year, for the first 3 years)
 - Both of them turned down our offer.
 - Reason: Problems in their spouse's job and cost of living concern

Current situation

- Both DME and civil service Forensic Pathologist positions are open.
- The least number of forensic pathologists to handle the current caseload should be 4.
 - Now we have only 3 = unsustainable
 - If we are down to 2 for any reason, this department is literally over.



- Nationwide shortage of forensic pathologists
 - About 40-70 medical examiner/coroner's offices are always recruiting.
 - An experienced forensic pathologist is hard to come by.
- Management/supervision work is never popular among pathologists.
- Disadvantage of Honolulu High cost of living
 - Salary Commission's Salary Study DME salary is competitive
 - Agree on the salary amount being competitive
 - But mainland pathologists consider cost of living (not cost of labor this study factored in) = Extremely discouraging factor
 - Many doctors have student loan debt They may be attracted to a job with high salary with low cost of living.

• DME has multiple additional duties on top of daily casework

- City-related work (shared with ME):
 - o Attending cabinet meetings twice a month
 - o Participating in city-related activities as an appointee
- Department-related work (shared with ME):
 - Attending management meetings once a week
 - o Supervising 3 forensic pathologists, 2 medical technologists, and 4 autopsy technicians: Performance evaluation
 - Updating policies and procedures work on NAME accreditation
 - Safety officer holding safety committee meetings, conducting safety training and inspection
 - o Personnel hiring process, investigation, discipline, updating position description, etc.
 - Purchasing managing grant, conducting procurement (including toxicology, body transport, purchase of expensive items), managing contracts (including experts including per diem doctors, forensic anthropologist, forensic odontologist, scuba gear inspection, etc.), purchasing necessary items with p-card and other methods, attending monthly meeting with Purchasing department
 - Budgeting: Work along the city's budget cycle, attending council meetings February/March, departmental personnel planning
 - Managing fiscal/spending
 - o Building renovation-related issues
 - o May work on former chief's backlog reports (difficult cases remaining)
 - Attend various meetings
 - Making lectures, presentations, etc. when asked
 - Troubleshooting a lot of urgent tasks fall into this category

- Unlike civil service Forensic Pathologist, job security is not guaranteed
 - Appointed by Mayor
 - No guarantee for reappointment at the time of Mayoral election
 - DME has a high level of job security due to its specialized nature, and applicants have to understand that.

- At this point, both DME position and civil service Forensic Pathologist position are open.
- Candidates may compare: Which job is more attractive?
