the Department of Budget and Fiscal Services, reports as follows:

The purpose of the resolution is to approve of the sale of a City-owned parcel
located at 1409 Pi'ikoi Street, also known as Pi'ikoi Mini Park ("the Park"), to RV Ventures,
Ltd. ("RV Ventures") for a total sales price of \$112,000, based on an appraisal completed
by the Department of Design and Construction ("DDC"). RV Ventures is one of the
abutting property owners to the Pi'ikoi Mini Park.

The Deputy Director of Budget and Fiscal Services provided a brief summary of
the resolution and responded to Councilmembers' questions.
