I'm submitting testimony in support for the amendment to purchase plastic tiles for the outdoor hockey rink located at Kaomaaik Neighborhood Park. My name is Jason Cummings and I have playing inline hockey for the better part of 30 years. I was born and raised in and still reside in Mililani. I witnessed firsthand the explosion of inline hockey in the mid 1990's. Inline hockey has come a long way in Hawaii and is seeing more and more interest from our keiki. When I was young, there was no rink to play at. The only place we had was the street or the basketball court. We were so grateful to see a rink built at Kaoma'aiku Neighborhood Park, however over the years the playing surface has deteriorated and is having a negative effect on the developmental, cost and safety aspects of the game such as:

• Being exposed to the elements has given the cement surface a sandpaper texture and causes "road rash" when players fall. Even when waring all safety gear.

• The cement also has an inconsistent surface where as some places are "grippy" to inline wheels and other surfaces are "slippery". This causes an increased risk to injury due to it being hard to judge your speed when turning or stopping, especially for beginner skaters.

• The rough surface also wears down inline wheels and sticks prematurely. It is not uncommon for skate wheels to only last a couple weeks and would need to be replaced. Inline wheels usually run \$40-\$70 a set. A new stick can run \$50-\$300.

• Roller hockey pucks only last half a game. The rough surface can wear out the puck in less than 15 minutes. This is a huge cost at around \$10 a puck. In a typical season around 100 or more pucks are used.

I ask the Honolulu city council to include funding for the installation of plastic inline hockey tiles at Kaoma'aiku Neighborhood Park. The new surface would provide many benefits to the hockey community. Some examples are:

• A safer and more consistent playing surface. It would provide more speed and control to the player.

• A huge cost savings. Sticks, wheels, pucks and other gear would last up to 10x or more on plastic tiles.

• A safer place for our keiki. The tiles will enhance the hockey program at HIHI Hockey as it provides the community a way for kids to learn sportsmanship, teamwork, community service and a sense of family.

I would like to provide support for the amendment to purchase plastic tiles for the outdoor hockey rink at Kaomaaik Neighborhood Park. This rink is used by Hawaii Inline Hockey Inc. (or HIHI), which is a competitive inline hockey program. The program is led by experienced, Native Hawaiian and Pacific Islander coaches who regularly enter medal-winning youth and adult inline hockey teams in National tournaments (e.g., the North American Roller Hockey Championships or NARCh). My high-school aged son was trained by HIHI coaches over the past decade, and now competes with the HIHI men's team in National tournaments. He, as well as other competitive HIHI players, currently have to take precautions to prevent damage to their equipment or personal injury when playing at the Kaomaaik hockey rink, because the rink's surface is cement. Falling on this surface at high speeds could result in injury and the surface can damage hockey sticks and wheels more easily than tiled surfaces. The installation of plastic tiles on the rink will address both of these issues, allowing the HIHI teams to practice more safely and with a higher level of intensity in preparation for National-level competitions. Moreover, the tiles will provide an overall safer experience for the numerous youths and adults who play inline hockey on this rink, regardless of their playing level.

Honolulu. I am also a former employee of the City and County, and I am familiar with the City's budgeting process. In my professional capacity, I work closely with Hawaii's business community every day and can offer a unique perspective about the importance of this city agency.

I wish to share my support for the OER team and its work and convey the importance of funding the important mission of this office, which is to build the financial resiliency of our entire Oahu community by uplifting underserved residents and businesses.

I was appointed in 2022 to serve on this inaugural body and was soon after elected Vice Chair of the Commission. I'm honored to be included in this group of highly accomplished Commissioners. They represent Hawaii's small businesses, the financial sector, the tech industry, nonprofit and more.

During my time as a Commissioner, I spent countless hours working with the OER staff and the other commissioners to research and understand the economic challenges and opportunities facing Oahu's community. This is a gamechanger for underserved businesses and entrepreneurs because it connects them to technical resources that will help scale up and grow their businesses. This is a critical tool which will boost opportunity and reduce economic disparity in underserved areas. OER is also a partner with other organizations that foster workforce development and work-based learning opportunities. This is critical to develop a skilled workforce and expand income horizons so we can keep our residents here in Hawaii.

In conclusion, although we may not be in the pandemic era, the state's economy is still reeling. More importantly, our local businesses are facing more challenges than ever before. Every industry is faced with workforce shortages, higher costs of doing business and mounting uncertainty about the future of Hawaii's resident and tourist populations. The current surface (concrete) works but has several factors that could be significantly improved with the advent of plastic tiles. First and foremost is wear and tear on player equipment. Hundreds of dollars are spent each season by each player just to maintain skate wheels and sticks in a safe and usable condition due to the abrasiveness of the concrete surface. Plastic tile would eliminate that need and allow families who may otherwise may not be able to afford the continued added expenses to continue to participate. Additionally, plastic tiles would eliminate seams in the concrete surface which, on occasion, can disrupt play (whether causing a puck to bounce errantly, tracking one's skate wheels in the seam, or catching the blade of a stick and cracking it). Again, plastic tiles (which once assembled are seamless) would eliminate these disruptions. Outdoor hockey is and has been a passion for both me and my 3 kids for over 15 years and it will continue to be for years to come. The hockey community in Hawaii and on Oahu particularly are extremely welcoming and provide a safe and healthy environment for both youth and adults. My name is Noah Tramuto and I strongly urge you to support Bill 12 and the purchase of plastic tiles for the outdoor hockey rink at Kaomaaik Neighborhood Park as it would greatly support our community by improving the quality and safety of the sport.

Currently, the rink has a concrete surface. This surface when mixed with dirt, leaves, and occasional rain becomes extremely slippery and unsafe for our players (especially our keiki and those new to the sport). Plastic tile would greatly enhance the amount of grip for our skates and would vastly improve the quality and safety of our playing experience.

When players fall on this surface, it is very common to receive significant scrapes or cuts. They may also endure bruises or fractured bones. With a plastic tile surface, objects slide much better. This means that players will likely never get cut or scraped on the surface and any impact to their body would be less intense than on concrete.

The concrete surface causes extreme wear on our equipment, especially the wheels which get torn up in a matter of a couple months. The equipment we use is expensive to replace. A plastic tile surface would greatly reduce the amount of wear on the equipment. For example, I have had sets of wheels last around two years while playing on a plastic tile surface. With a plastic tile surface, more keiki and families will be able to afford to play for years to come.

The plastic tile also affects the way that the puck moves along the surface. Unfortunately, no matter what hockey puck we use, the pucks tend to roll over a lot more frequently on the concrete surface when compared to tile. The puck is instead to slide across the surface for passes and shots. When the puck consistently rolls instead of sliding, it drastically decreases the amount of plays that can be made (passes, stickhandling, shooting). When our local teams go up to the mainland to compete in tournaments that use plastic tiles, our players are unprepared due to the difference in surfaces and the way the puck behaves. With plastic tiles at our local rink, our players would better represent Hawaii while competing in the mainland.

Overall, adding plastic tiles to our outdoor hockey rink in Mililani will greatly benefit the hockey community on Oahu. With more safety and affordability, the plastic tiles will ensure that our hockey Ohana will be able to grow and spread Aloha across the island and even to the mainland.

Aloha,

I am writing in support of bill #12 to be used for the installation of hockey tiles on the skating rink at Kaomaaik Neighborhood Park in Mililani. Our kids have been playing roller hockey for about 3 years and have learned so much about sportsmanship and being team players. They have played at the tiled indoor rink in Kapolei and now at the outdoor rink in Mililani, so we have seen firsthand the difference a playing surface makes. Tiling the court would make a significant difference in both the playing experience, and most of all, significantly improve the safety of the players (the majority being kids).

Playing experience would be greatly improved by installing tiles. Tiles are superior to concrete because they are designed with a specialized texture to grip with skate wheels, while being smooth at the same time to hold momentum and speed. Our kids often represent Hawaii in tournaments on the mainland and are at a disadvantage with the teams there because they are not able to practice on a surface that is on-par to what the mainland players use. They sometimes even fly up a day early and rent time at a rink to get used to the playing surface. A proper playing surface on our local court would would help to equip our kids to better represent our state.

The second and most important reason for installing tiles is safety for our keiki and all players who use the rink. Currently the surface is concrete that has been worn with natural wear and tear over the years, becoming rough and uneven. Skate wheels catch in small divots or cracks in the slab, increasing trips and falls. Although the players wear proper protective gear, falls still cause injury, so minimizing falls is of utmost importance. The concrete materials itself is also very rough and hard, frequently causing abrasions and bruising upon impact. Tiles would be smoother and have a slight give to them, which would decrease injury. Tiles would also help the player's gear to last longer and not get torn up so quickly. Currently players outfit their sticks with makeshift plastic guards, which wear down and need to replaced almost weekly. Their skate wheels also need to be replaced at an alarming rate, making the sport more expensive than it needs to be, which is a financial challenge for us, and may be a complete barrier for many families who want to get into inline hockey.

We urge you to support this bill and thank you for considering our testimonies.

My name is Chris Lee and I am a Honolulu resident and the Founder and Director of the Academy for Creative Media System at the University of Hawai'i. I write today as a private citizen in regards to the funding of the Honolulu Film Office.

Honolulu is fortunate to have a seasoned and trusted Film Office with extensive industry connections and experience. Whether it's dealing with the networks and studios, independent filmmakers or assisting our students with their permits, the Honolulu Film Office is always there to help. And they do so always with aloha.

Honolulu is also blessed with a vibrant and growing production industry, in part because of the excellence of the Film Office. A review of the direct spend numbers show the scope of this enormous economic engine for the city that the Film Office must manage.

Hawai'i's production industry has climbed to a DBEDT reported average of \$396 million dollars in direct spend per annum, the vast majority of which is generated on O'ahu. In DBEDT's latest figures from 2022, the total Hawai'i film production direct spend was \$420.04 million (includes qualified tax credit spend and non-tax credit spend).

The breakdown by island is as follows: O'ahu: \$354.88 million; Hawai'i County: \$39.32 million; Kaua'i County: \$12.56 million; Maui County: \$13.28 million. With Hawai'i household income generated at \$168.02 million and tax revenue generation of \$45.36 million, DBEDT estimates the total economic impact from film production on our economy at an impressive \$726.68 million. Most of that is generated in and for the City and County of Honolulu.

The University of Hawai'l is entering into negotiations to partner for the state's first major studio complex at UHWO. The goal is to grow that \$400 million a year in production to \$1 billion. That requires the full time services of the Honolulu Film Office.

It has come to my attention that the Honolulu Film Office budget has been proposed for a budget reduction. I was shocked when I learned this might occur. Please let me share why this office is vital to attracting, hosting and managing the wide scope and breadth of the industry on Oahu and the budget cuts should be restored.

I was born and raised in Hawaii and very fortunate to find a successful career in the Entertainment Industry. I have worked and scouted all over the United States and Internationally on major motion pictures, including many projects in Hawaii, (ie: Battleship, Jurassic World 1 & 2, Jumanji, Jungle Cruise, and Chief of War.) for some of the largest production companies in the world including Disney, Universal, Sony and Apple)

If you want a successful production, any form of filming, whether it is a large major motion picture, a TV show or a commercial it <u>requires</u> multiple levels of involvement from the local film office. Oahu is the hub of Hawaii's production industry and virtually all of the filming requests that shoot on Oahu interact with the Honolulu Film Office, who greets them with Aloha and guides each one so they can have a successful shoot that meshes well with the needs of production and the needs of the community.

Having worked with many film offices in the US, across Europe and Asia, Honolulu's film office is an excellent example of what a great film office should be. While representing the Aloha spirit of Hawaii, it is very efficient and most importantly quick to respond and find answers, solutions and/or resolve issues.

Filming is a creative process, and it can be complicated and fluid. Walea Constantinau and her staff are dedicated professionals who I have been fortunate to have their assistance in finding filming sites, mitigating potential issues, and if need be, problem-solving together, working with production to find equitable solutions.

I know first-hand the economic benefits filming creates in Hawaii. Aloha Committee Chair Cordero and Committee Members:

Trees for Honolulu's Future (TFHF) is a nonprofit organization with a vision for a tree-filled island that preserves and enhances our quality of life, especially in the face of climate change.

Trees create multiple benefits well documented by research. They create shade and use evapotranspiration to lower temperature. Trees recharge groundwater and decrease surface runoff protecting our reefs. Trees trap pollutants and store CO2. Trees calm traffic. They are critical infrastructure. Numerous jurisdictions, including Honolulu, have recognized this, and are making tremendous progress in greening their cities.

In 2018, the City Council unanimously adopted resolution 18-55 setting a goal of achieving 35% urban tree canopy by 2035. Last year the Council put oomph behind that policy by adding \$700,000 to the FY24 to plant trees. Mahalo! The Administration released the funds and the City's Division of Urban Forestry (DUF) produced a sound plan, with community engagement at its core, to execute the Council's directive. Throughout TFHF has been working with the Department of Parks & Recreation (DPR) to increase the urban tree canopy on O'ahu. This is all good.

Our worry, however, is that sufficient monetary resources are allocated for maintenance of trees. Community can come together to water newly trees in parks and residents who agree to water City-owned and planted street trees adjacent to their properties, yet structural pruning and longer-term care must be provided by either professionals within DPR or outside contractors. This takes money. We urge the Council to ensure that DUF has adequate funding to provide services that result in healthy and safe urban forest. We note that unlike most infrastructure, trees appreciate in value over time, not depreciate. They are, in short, worth the investment. Please ensure adequate funding for maintenance of trees. This is not an area to be "penny wise and pound foolish".

We thank those within DPR and the Administration, along with the Council, for working to make Honolulu a more livable and resilient city.

I am writing in strong opposition to the amendment that would cut the funding for the film office.

I am a key assistant location manager working in the film industry for 8 years. I am born and raised on the island of Oahu and have been lucky enough to stay on island to continue to work. I am also a member of the local Teamster 996 union.

I work closely with the City & County Film Office in permitting for the various filming productions. I have worked in TV shows, movies, as well as helping in smaller productions, each having their own various footprints and unique inquiries. I believe a large part of being able to film on island is due to collaborating with the City's Film Office. In my experience, about 80% of the permits I would usually submit have been processed through the City. I have great confidence in their knowledge and experience. They take the time to meet onsite and facilitate communication to better explain with Park Managers, Community members and Production on the best ways to proceed.

For example, for an upcoming project, we met with the Film Commissioner as well as the Park Manager about potential locations to film. They were able to give us information and recommendations on best areas that may work logistically for the Production as well as for the Parks and the community. We were able to narrow it down to 2-3 solid viable options to present to production. That kind of certainty is important as a large project plans to move forward. Productions have to make plans that end up locking them into a set creative direction so the ability to get the kind of preliminary info we got was so helpful.

The film industry has shown a steady increase in projects coming to the island to film over the last decade, too much for one person to handle. The addition of staff in the last couple of years to assist with the high volume of requests was long overdue. The prospect now of not having any staff due to cuts to the budget is daunting for the industry.

Because of this, I am writing in opposition to the suggested amendment, to reduce the budget of the Honolulu Film Office or require it to be funded federally.

I am testifying in strong opposition to an amendment to Bill 12 that would reduce or eliminate funding for the Honolulu Film Office.

My name is Cheryl Sakai, and I am an Assistant Location Manager and member of Hawaii Teamsters 996. I am proud to say that I was raised in Honolulu and have worked in the production industry for almost two decades, since 2006. My resume consists of a variety of local productions from various commercials, network episodic (CBS's "*Magnum PI*"), non-profit (PBS Hawaii's "*Na Mele*"), and major motion pictures (Disney's "*Lilo and Stitch*"). On every production, I have worked closely with the City & County of Honolulu Film Office, which is helmed by Walea Constantinau.

With the world-wide success of productions like, "*Lost*" and the "*Jurassic Park*" franchise, Hawaii has seen the positive impacts of the production industry. This is possible thanks to the City & County of Honolulu Film Office. From street usage such as a car chase on "*Hawaii 5-0*," to Jason Mamoa walking through Heeia Forest on "*Aquaman 2*," to a rescue scene on a sandy beach on "*Doogie Kamealoha*," the film office facilitates all of these city locations. They are often our first call when conceptualizing a location for filming, and they work closely with us until it is captured on camera. Hawaii has become a sought-after place to film on-location because this film office makes it possible.

On August 25, 2020, our production industry was issued a City and County Emergency Order 2020-25, from Mayor Kirk Caldwell. The order, "defines Film and Television production as an essential activity, and therefor allows this activity to operate." As an essential worker, I was able to return promptly to work in August of 2020 on a streaming feature film for Netflix, titled "*Kate.*" One of the first points of contact was the Film Office, as they paved the way for our production to begin collaborating with various city locations for filming. This would not have happened if the film office had not worked with the industry to figure out how to safely return to work… it's a validation of the economic importance the production industry is to the city. And a confirmation of how much we rely on the film office to keep the production wheels turning. Oahu was one of the first places in the country to be able to go back to work and because of that, we attracted series like *Doogie Kamealoha* and others. The film industry spent over \$300 million in our economy at a when we really needed it.

I am not only testifying in strong opposition of Bill 012, but I would like to argue for more funding, for this essential office. Recently, they were able to hire two employees who were able to expertly execute our requests while thinking of the needs of the public. The film office serves both the people of Honolulu and the film industry. We need this essential office to be able to do our work.

This is a relationship-oriented business and the Honolulu Film Office understands this and operates with Aloha each day to help our industry grow, and that is good for everyone.

Respectfully, I am requesting that you restore funding to the Honolulu Film Office.

My name is Rita Wilcox and I strongly urge you to support Bill 12 and the purchase of plastic tiles for the outdoor hockey rink at Kaoma'aiku Neighborhood Park. The following best describes how this purchase would significantly enhance the safety and quality of the sport of hockey that my children and I love playing here on the beautiful island of Oahu.

First, as a parent of two hockey players and a player myself, I am constantly looking out for the safety of any activity that we commit ourselves to. The purchase of tile for this rink would greatly benefit both players and goalies alike. For my daughter and myself, we skate out and play both offense and defense, and my son plays goalie or "in net". The upgrade to tile would allow all who skate to avoid mishaps caused by the seams in the cement of the rink surface. There is a major seam that runs through the mid-section of the rink. I myself have gotten my wheels caught in this on multiple occasions and have met with the concrete in uncoordinated and ungraceful falls, luckily without serious incident until now. My daughter has had collisions with others on account of someone getting wheels caught and has skinned up her knees when the surface has grabbed her leg pads and exposed her knees. My son, who is a committed goaltender, has had his rollerflys and pads caught when trying to slide across the crease to defend the net and has had his hips twisted and jolted quite badly as a result of this crease. Falls and purposeful moves by goalies would not be as hard with the tile surface and would keep all safer while enjoying this great sport.

This brings me to my second reason for the tile upgrade. The cement is very hard on the lifespan of the equipment needed: protective gear, wheels, pucks, and sticks used to play the sport. Families like mine are constantly having to purchase wheels at an alarming rate because they wear so quickly on the surface. Sticks are worn thin and protective wraps, tape, and sticks or stick blades need to be replaced constantly. Even gloves and other gear do not meet without major wear and tear from contact with the abrasive cement. Since there are no equipment stores that supply hockey needs here on the island, families are forced to purchase online from the mainland and pay for shipping which can add up quickly. For families trying to have a safe and positive outlet for their children and themselves this becomes quite a financial burden. With the upgrade of the surface to tile, many families would spend less and enjoy their time at the rink knowing that they have a safe and positive environment to play in.

Thank you for your time and for considering my perspective and opinion on funding Bill 12 and the purchase of plastic tiles for the hockey rink at Kaoma/aiku Neighborhood Park.

My name is Krisha Watamura, and I am writing in support of Bill 12 and the purchase of plastic tiles for the outdoor hockey rink at Kaoma'aikū Neighborhood Park in Mililani. It would greatly increase the safety of the sport for all those who play outdoor hockey.

My family and I have been a part of the outdoor roller hockey organization, Hawaii In-Line Inc (aka HIHI) for almost a year and it's become an integral part of our every day life. My children play in the league, my husband plays in the league and volunteers to help assist the bench coaches and practices, and I also volunteer every Saturday to scorekeep for the games. In fact, most families that participate in HIHI also offer up their personal time to help assist in various ways - many of them volunteer to ref, some volunteer to help the young keiki learn to skate (which is a free program offered through HIHI), some volunteer to scorekeep alongside myself, some volunteer by assisting coaches with practices. It has become an Ohana to us.

The plastic tiles would be extremely beneficial to the outdoor hockey program, in terms of safety and retention of gear and equipment. Currently, the players are skating on a concrete pad that was laid several decades ago - and while it's held up over time, there are still creases and imperfections that can cause players to trip and fall. Falling on the concrete slab is not pleasant, at all. All of the players are always geared up to the fullest - helmets, shin-guards, elbow guards, gloves, etc, but it still doesn't stop the pain that comes from slamming into solid ground. My son has broken his wrist and my husband got a small concussion from playing hockey on this pad; both are healed and continue to play because they love this sport, and they love this organization. If we had the plastic tiles installed at the outdoor rink, the skating would be so much smoother and the falls would be less traumatic, especially for our keiki who are just learning how to skate and play the game.

Not only does HIHI organize the outdoor rec league at this park, but they also organize teams for travel tournaments. Almost, if not all, of the rinks that they travel to for these tournaments have rinks comprised of these plastic tiles, and it would be wonderful if our local teams could have the same foundation laid out for them as other teams across the country. These kids give 1000% to these games and often bring back trophies (and bragging rights) to Oahu. Many people underestimate the kids from Hawaii because not many people associate Hawaii with hockey (roller or ice), and with hard work and dedication - and the right training facility - I know this organization could create a big name for themselves in the hockey world.

Another benefit of these tiles would be the retention of hockey gear and equipment for the players. Hockey gear is extremely expensive, and living in Hawaii with very few sport equipment resources, we often have to rely on our gear coming from the Mainland and hefty shipping expenses right along with it. With the rink in it's current state with the concrete pad, my family and I are constantly going through gear. The skate wheels need to be changed constantly - the rubber does not hold up well against the harsh surface - and the skates are also getting worn down quickly. We are going through hockey blade protectors all the time. The blades of hockey sticks are not meant for cement, so in order to protect them, we have to buy blade protectors and they only last a few weeks, at best. Player clothing/jerseys get torn, shin-guards get worn down from falling/sliding constantly...it's a battle just to keep ourselves fully equipped. The tiles would be such a blessing just for finances alone. The sport of hockey is not cheap, so anywhere we can find to save money would be amazing!

Mahalo for your time and considering my thoughts and opinions on this matter. If this passed, it would benefit so many families and keiki, not just in Mililani but across Oahu.

My first point will be about safety, the safety of myself and others. Being a part of the youth category I know that when I play I don't want to go home all hurt and busted up from falling on the concrete asphalt that we have. Tiles would make it possible so that me and others don't have to go home in a rough shape. After all, we as a hockey community just want to have a good time playing our sport. Tiles would ensure a much more graceful fall that would still hurt but not as much as getting your knees and whole body cut up from sliding across the concrete that we have. Yes, we do have gear but when we fall our gear shifts to different sides of our legs and arms and also shreds down our gear making the next fall even more likely to be worse than the last.

Coming to my second reason for why tiles would be a great improvement for us in Kaomaaikū Neighborhood Park is that tiles would make playing a lot more fun and easier to skate. You see we have a crease that runs down the middle of our rink. As well as smaller creases that branch off from the crease in the middle, and while skating I know that a lot of us hockey players get our wheels stuck in this crease that sometimes causes us to trip a little or completely fall onto the floor. Getting tiles would help with a much smoother gameplay and overall much more fun experience than tripping over a divot in the middle of our rink that is risking our health and safety.

Not only would having tiles be amazing but it would be a good combination with Bill 13, where we want to install a roof and lights. Adding a roof would protect the tiles from any damage and also would be a great safety measure.

As I've said I'm concerned for the safety of myself and others. Tiles would be very very helpful and amazing to have here at Kaomaaikū Neighborhood Park. As a youth player that has been playing hockey for as long as I can remember, I wanna feel safe playing hockey, and I'm sure everyone else does, plus we all just want to have a good time doing the things we love to do.

The film office is the liaison for every size and scope of project that shoots on Oahu - from a smaller local commercial to a network television show, or a blockbuster feature film - the film office has consistently been so helpful and an absolutely necessary intermediary between the production company, the location department and multiple city agencies. In addition, their dedication to community outreach, with us and on behalf of us, has helped both production and the community tremendously. Our interaction with the film office has helped us work smoothly and successfully with everything from action scenes with actors jumping from one rooftop to another Downtown, to scenes with a couple walking in a neighborhood, to a scene with actors stuck in an airplane in the jungle.

Many local people have been able to build a career out of Hawaii's industry and have not had to leave and go work on the mainland. The film industry pays a livable wage, allowing locals to remain in the islands where their hearts and families are. The good work the Honolulu Film Office does -- whether it's helping to attract a production to come here, being with us on the street during road closures or working with us and the community – they help us make it happen. They are a key factor in making it possible to film here.

Hawai'i is a desirable location to film in the world but it takes a lot of work to make it all work. Support of the film office is essential to our business. Let's please remember all of this and not cut the funding for the film office.

Aloha mai e nā Honorable Council Members,

Approving the Office of Economic Revitalization's (OER) proposed budget is a vital investment in essential and sensible programs aimed at fostering fair economic growth within our County. A mere glance at the latest Alice report underscores the urgency of achieving equitable economic development. For instance, 75% of kanaka 'ōiwi 'ohana live below the Alice poverty threshold. 75%! Recent findings have highlighted Honolulu not only as the most unaffordable major U.S. city but also as the world's fourth least affordable, trailing only Hong Kong, Sydney, and Vancouver.

The OER has delivered on their mission for our County over the past few years, such as how it managed its groundbreaking efforts to channel nearly \$400 million in pandemic relief funds. As the OER concludes these initiatives, it is embarking on new programs aimed at continuing the creation of much-needed good jobs, including:

- 1. A new grants contractor to target much needed federal co-funding
- 2. The Small Business Loan Initiative (HUD CDBG Section 108 funded)
- 3. Incubator and Accelerator funding
- 4. Digital Equity projects
- 5. The Oahu Business Connector (OBC) designed to accelerate Inclusive Entrepreneurship

I end with a personal story of just how important City funding is to foster equitable economic development. I co-founded the Purple Mai'a Foundation (PMF) a decade ago. At that time, computer science education was not equitable. Just three public high schools offered more than introductory courses. We kicked off PMF with City workforce funding that we used to hire our first employee. Since then, we've evolved into a diverse organization investing over \$4 million annually in STEM education, STEM workforce development, and entrepreneurial capacity building. For instance, our workforce development program has graduated eight cohorts with average starting salaries of \$88,500. Last month, without our solicitation, a continental donor gifted us \$2,000,000 to expand what we do here for more of our residents. City support was absolutely vital in facilitating the launch of Purple Mai'a during our formative years.

My name is Katie Petronio, the hockey community knows me as 'Boo', I was born and raised in Mililani and my family was one of the original plank holders of Mililani Inline Hockey Association (MIHA). I moved to the mainland when I was 14, was recruited to play on an elite Tier 1 Women's U19 team which competed internationally prior to being recruited to play hockey at Bowdoin College in Maine. I am a LtCol in the USMC working at Camp Smith, yet I know I owe much of my life success to MIHA and the amazing community of hockey players who devoted every afternoon to linking up at 10 acres and training till the lights came on....and we loved it.

Lately we have been posting old MIHA team photos on facebook and it dawned on me that we are all very successful and respectable members of society. At first, I thought that was coincidence but no, it's not. We have become Professors, nurses, business owners, firefighters, teachers, work in corporate and a respectable amount of Civil Servants and DoD members. This is not be accident, see the same characteristics and traits you learn in team sports, are the same skills you need to be successful in the business sector; team work, unselfishness, resilience, commitment, overcoming adversity, reliability, mental and physical toughness. Its more than a game, it's a road map to character development that will ensure your success in life, and our youth need to experience this.

I am fortunate to have been born in the 80's prior to cell phones, IPADs, free play video games as our youth better reflect zombie than the next great generation. In 2022, DoD conducted a study on military aged youth and found that 77% of our population is not qualified to serve with out waivers for their poor physical fitness, drug use and mental health waivers. That's beyond concerning, we need to get our youth out of the house, away from devices and focused on healthy habits such as team sports that are affordable and accessible. Prior to HIHI standing up, there were two program on island, both were costly and both presented limited court time; one day of practice and one day of games a weekend. Youth looking for additional skate time had to pay \$15 (both parents and kids) which quickly adds up to 50-100\$ a week. This created an economic barrier for some families who could not afford extra access. In addition, with dual working families, the windows for available skate time were not conducive to those who work later in the evening or in town.

Once HIHI was established, we immediately saw an increase in youth and adult participation outside of their scheduled practice hours because the court is open and FREE to the public and not run on strict operating hours. Its evident that our youth skill base has grown tremendously because they have drastically increased their court time. With that said, the rink surface presents another set of challenges, due to the rough finish, players are wearing out their wheels, shin pads, sticks and pants/shorts during falls driving up the sustainability/cost per player. While the season is very low cost, the course surface of the rink demands frequent wheel and stick replacements in addition to shorts. Players to often get large scrapes on their sides when they fall resulting in a reasonable amount of tears and timid players. Tiles would

greatly reduce the rate of equipment replacement and allow for fast practices with the correct puck while easing the pain of impact. This is an imperative upgrade if we want to create an environment where the youth and adult players can compete overseas.

The Math is pretty simple, we can invest in rink improvements that will promote healthy activity for players of all ages, create community engagements, and develop youth sports that are affordable and accessible or we can miss this opportunity and invest 10 years down the line on drug rehabilitation, homelessness, mental health issues, unemployment, suicide, obesity, etc.

I am local Location Manager who for more than 25+ years has worked on big budget feature films like PEARL HARBOR, television series like LOST and the new HAWAII FIVE-0; and countless Hallmark movies and commercials. When I heard there were proposed cuts to the film office, I was in disbelief. They work so diligently and are really good at what they do. Our success as an industry is due in large part to the knowledge and understating of how to work collaboratively with the industry.

Frankly, I just can't see how we can have an industry here in Honolulu without it. It would be like expecting the Honolulu Marathon or parades to be coordinated and permitted without a Street Usage Office.

The film industry is often like trying to fit a square peg in a round hole... we routinely ask for unusual things, and we as an industry rely on the film office's expertise to figure out how to make our logistically and creatively complex requests work for our shows and the community, and do it in the quick turnaround timeframes that the industry demands.

In addition, we often work hand-in-glove with the film office to attract projects, working closely together at the early stages of development to put Hawaii's best foot forward when a studio or streamer is trying to decide where they will shoot their film. Be it gathering visual data or solving creative challenges that address their needs to bring the work into town, the film office has become in invaluable partner.

Based on my strong first-hand knowledge of what the office does, I respectfully request the restoration of the funding so that the Honolulu Film Office can continue to do its invaluable work that helps our industry thrive.
