The Department of Planning and Permitting (DPP) is the enforcement arm of the City and County of Honolulu as regards real property. In its attempts to enforce the 30-day minimum rental ordinance (19-18) currently in effect, it has engaged a third party which has provided a bot—a computer application that searches for certain parameters within short-term rental hosts' online listings. Clever. But the DPP has violated the U.S. Constitution's 8th Amendment which prohibits excessive fines.

If you are caught driving drunk (and thus at risk for maiming and killing people) your fine is a well-deserved \$1,000. But if you are an honest, humble short-term rental host who is no IT wizard and the bot found that you had a less-than-30 day stay setting deep in your AirBnb or VRBO listing that you were unaware of, the DPP will threaten you with a \$10,000 a day fine for your "crime!" The DPP's practice varies. Some of the (mostly elderly) people who inadvertently get themselves in the DPP's cross-hairs are given 7 days to cure (make things right). Others are given 5 days. Some are simply slapped with the \$10,000 per day fine with no time to cure. Victims of these practices have been unable to discern the logic for these inconsistent enforcement attempts.

If you want to appeal the DPP's decision, you must know the following, because nobody is going to tell you if you don't know enough to ask: 1. To appeal, you must write a letter to the Zoning Board of Appeals (ZBA), enclosing a \$400 fee in order to be heard. 2. You must find out the date your case will be heard. You may show up to your hearing or do it via zoom. 3. Since there aren't enough volunteers on the ZBA to have the quorum necessary to come to a legally binding decision, all the ZBA does now is postpone any decision-making to the following year. 4. If you ever get a decision against you (and who needs a \$10,000 a day fine hanging over their head?) and you can't come up with the money, a lien will be placed on your property. Not only that, but your ability to do ordinary transactions with the City and County government will be curtailed. No driver's license renewal. No new car registration renewal, and so forth. You may even lose your property to non-judicial foreclosure.

Knowing these things, I am certainly NOT in favor of having fine money go directly into the DPP's coffers.

The DPP should be held accountable for its lack of efficiency and productivity. The moneys destined for the DPP that go into the general fund should be doled out like an allowance to an unruly teenager. So many permits per month, so much money.

Again, NO on this measure, not only because at present there is no carrot to get the DPP moving in the right direction, but it seems to me a conflict of interest. Let's not foment any more gray ethics areas here.
