RESOLUTION

CONFIRMING THE REAPPOINTMENT OF ANTHONY MIZUNO TO SERVE ON THE ECONOMIC REVITALIZATION COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-109, Revised Charter of the City and County of Honolulu, 1973 (2017 Edition), as amended ("Charter"), establishes an Economic Revitalization Commission ("Commission") consisting of nine members; and

WHEREAS, Charter Section 6-109 sets forth the duties of the Commission; and

WHEREAS, pursuant to Charter Section 13-103, the members of the Commission are appointed by the Mayor and confirmed by the City Council ("Council") and serve for staggered five-year terms; and

WHEREAS, by Mayor's Message 24 (2024), dated February 8, 2024, the Mayor has reappointed Mr. Anthony Mizuno to the Commission; and

WHEREAS, if confirmed by the Council, Mr. Mizuno will serve for a second term to expire on December 31, 2028; and

WHEREAS, Charter Section 6-109(h) requires that the Commission members have expertise in small business, finance, sustainable economics, and community development; and

WHEREAS, Charter Section 13-103 requires that each appointee to the Commission member be a registered voter of the City; and

WHEREAS, the Council has reviewed Mr. Mizuno's qualifications and character and finds that he qualifies to serve on the Commission; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the Mayor's appointment of Mr. Anthony Mizuno to the Economic Revitalization Commission for a term to expire on December 31, 2028; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Mr. Mizuno for his commitment and willingness to actively participate in city government; and
