As a longtime Pupukea resident who walks the beach at Waimea every day and swims every day that conditions permit, I have observed our heroic lifeguards for more than 30 years. It has never made any sense to me that they should be in the same department with paramedics and ambulance personnel. If I found myself in a dangerous, life-threatening situation in the ocean, I certainly would not want to be rescued by EMS, just as I wouldn't want a lifeguard putting out a fire at my house.

Firemen have their own department and are supervised by people with actual fire-fighting experience. The same should absolutely be true for lifeguards.

Although it may sound like the most democratic path, I am strongly opposed to making this a ballot measure voted on by the general public, for all the reasons so eloquently outlined by Councilwoman Andrea Tupola on a previous hearing on this measure. This is a complicated issue, and if the public has not taken the time to attend the hearings as I have, then their tendency will generally be to vote No.

Please allow the Mayor to exercise the powers he has been given and establish a separate department for Ocean Safety immediately.

Aloha Chair Weyer and members of the Committee-

I support RES24-050 as the preferred method for standing up a Department and Commission for Ocean Safety. RES24-050 provides the cleanest path forward for public oversight and transparency while keeping the chiefs of Ocean Safety in leadership.

While the intent of RES24-103 is good, I do NOT support the current language of RES24-103 where the Mayor appoints directors.

In light of the suspension of Chief Titchen with an unclear reason it has lead the public, lifeguards and supporters to speculate whether this suspension is based off a difference of opinion between the Mayor and Chief. 24-50 did not go unnoticed through the council. It has been passed unopposed by the council during 4 separate hearings over a span of about 2.5 months.

As the dust settles it may be wise to defer 24-50, 24-92 and 24-103 to next year which is a charter year.

I have a few questions if 103 does pass and 92 goes to the ballot for he administration and the council.

Why is there such a huge rush to get this done now? What happens to the Mayor appointed directors of 103 if 92 is passed in November?

Acknowledging that recent events have catalyzed what seem like opposing views on how to move forward, I want to remind everyone here that our workforce us absolutely united on the need to create a department for Ocean Safety that is separate from Emergency Services.

I am here to represent myself and many of my co-workers in the supporting Resolution 103 and to thank all of you and the Mayor for offering this expeditious solution. I truly believe that Resolution 103 is the best way to give OSD the means to succeed.

Standing up OSD right away with an appointed Director hastens OSD's independence. But just as importantly, this route comes with a tacit pledge of support from the administration, ensuring OSD of the Mayor's support in the critical first years of independence. This cooperative relationship is critical for OSD to thrive.

If down the road, a commission or other change to the governance of the department is deemed in the best interests of ocean safety, that too can be considered by our rank and file, the Council and Mayor. But the time to stand up the department is now.

As lifeguards we spend our days mitigating risk, educating the public, and taking action in a rescue situation. My support of Resolution 103 represents this same process: educating (myself), assessing risks, taking action. Resolution 103 is clearly the quickest, least risky, most assured path to delivering an independent and successful OSD. It has my full support.

I am here to support OSD moving forward.... not backwards nor into a political quagmire.





Opposition to Resolution 24-103

April 30, 2024

Testimony by Edward Fujioka

Resolution 24-103

Aloha Chair and members of the City Council thank you for the opportunity to testify on Resolution 24-103. I am a retired first responder and I am opposed to this resolution.

This Resolution allows the Mayor to select the Director (Chief) of Ocean Safety. I believe that this resolution is short-sighted and detrimental to the well-being of our community.

The Commission

Public Safety commissions across the State are established for public safety agencies like Fire and Police. The Commissions select, evaluate, rate and ensure all public laws and agency policies and procedures are followed, updated and followed. The selection of the head of Ocean Safety is critical to the success of the agency. In a recent news article, it was mentioned there a very few qualified candidates for the position. The commission can conduct a national and/or global search of candidates to find candidates interested in the position.

Conclusion

I strongly oppose Resolution 24-103 and urge the city council to reject it. Establishing a Ocean Safety and EMS Commission the City Council will uphold its responsibility to protect and support public safety services that the residences and visitors of Oahu deserve. I am hopeful the city council will make the right decision and vote NO on Resolution 24-103.
