Your Committee on Public Safety, which considered Resolution 24-224 entitled:

"RESOLUTION ACCEPTING A GIFT OF THANKSGIVING MEALS VALUED AT
\$17,155 TO THE CITY FROM THE HONOLULU FIREFIGHTERS FOUNDATION
(HFF) FOR ON-DUTY HONOLULU FIRE DEPARTMENT (HFD) PERSONNEL,"

transmitted by Departmental Communication No. 650 (2024), dated September 3, 2024,
from the Honolulu Fire Department, and introduced on September 6, 2024, reports as
follows:

The purpose of Resolution 24-224 is to accept a gift to the City valued at
\$17,155 from the Honolulu Firefighters Foundation ("HFF") of Thanksgiving Day meals
for on-duty Honolulu Fire Department ("HFD") personnel.

Section 13-113 of the Revised Charter of the City and County of Honolulu 1973,
as amended, provides as follows:

The Council, on behalf of the City, may accept gifts or donations of money,
securities or other personal property or of real estate or any interest in real estate.

To implement this Charter provision, the Council adopted Resolution 05-349, CD1,
FD1, which establishes guidelines for the solicitation and receipt of gifts on behalf of the
City.
