ACCEPTING A GIFT OF \$3,333 TO THE CITY FROM HAWAIIAN LIFEGUARD ASSOCIATION FOR THE DEPARTMENT OF OCEAN SAFETY'S JUNIOR LIFEGUARD PROGRAM.

WHEREAS, Section 13-113 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended, provides the City Council ("Council") with authority to accept gifts to the City; and

WHEREAS, Resolution 05-349, CD1, FD1, establishes a policy of the Council for the solicitation and acceptance of gifts donated to the City; and

WHEREAS, the policy provides for the acceptance of the gift by affirmative action by the Council; and

WHEREAS, through a letter dated September 17, 2024, approved by the Managing Director, the Acting Director of the Department of Ocean Safety has submitted a request to the Council for acceptance of a gift to the City from Hawaiian Lifeguard Association of \$3,333 for the Department of Ocean Safety's Junior Lifeguard Program; and

WHEREAS, the description and value of the gift are set forth in the Declaration of Gift attached hereto as Exhibit A and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that this body gratefully accepts the gift of \$3,333 from Honolulu Lifeguard Association that is more fully described in the above-mentioned letter dated September 17, 2024 and the Declaration of Gift attached as Exhibit A; and
