A BILL FOR AN ORDINANCE

RELATING TO PLASTIC.

BE IT ORDAINED by the People of the City and County of Honolulu:

SECTION 1. Purpose and findings. The purpose of this ordinance is to address certain single-use plastic containers.

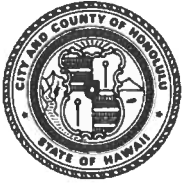
The City Council finds that plastics entering the environment have had a demonstrable adverse effect on the health of the people of the City and County of Honolulu ("City"), as well as the environmental integrity of our islands. Single-use plastic containers have been major contributors to street and beach litter, ocean pollution, harm to marine and other wildlife, and greenhouse gas emissions. A significant portion of marine debris – estimated to be 80 percent – originates on land, primarily as escaped plastic refuse and litter in urban runoff. Certain single-use plastic containers, such as polyethylene terephthalate bottles, do not readily break down, and instead degrade into pieces and particles of all sizes, including microplastics, which can subsequently enter human bodies through the food stream and have been linked to serious human health problems.

To protect the health, life, and property of the City and its inhabitants, the City has enacted ordinances to regulate the use of single-use plastic goods and bags, as well as certain plastic foodware. Reducing the amount of non-degradable and non-recyclable waste that enters the City's waste stream is consistent with the City's Integrated Solid Waste Management Plan and the State-level Aloha+ Challenge to "support changes in design, material use, and manufacturing that reduce waste and toxicity" and to "significantly reduce the annual generation of solid waste." While the rate of plastic bottle recovery in Hawai'i is approximately 37 percent, readily available alternatives such as aluminum containers enjoy a recovery rate of 55 percent, and cardboard containers can be readily burned to fuel the City's power needs through the H-POWER plant. The diversion of plastic bottles from the City's waste stream further supports the City's efforts to reduce the annual generation of solid waste.

SECTION 2. Chapter 34, Revised Ordinances of Honolulu 2021 ("Regulation of Businesses"), is amended by adding a new article to be appropriately designated by the Revisor of Ordinances and to read as follows:

"ARTICLE __: SINGLE-USE PLASTIC BOTTLE

§ 34-__ .1 Definitions.

For the purpose of this article, the following definitions apply unless the context clearly indicates or requires a different meaning.

Disposable. Designed to be discarded after a single or limited number of uses and not designed or manufactured for long-term multiple re-use.

Plastic. Any material made of fossil fuel-derived or petrochemical polymeric compounds and additives that can be shaped by flow.

Plastic Bottle. A formed or molded container made from any type of plastic having a relatively inflexible fixed shape or form with a neck that is smaller than the container body.

Single-Use. Has the same meaning as disposable.

§ 34-___.2 Restrictions on single-use plastic bottle.

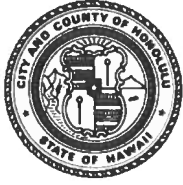
Unless exempted by this article, no single-use plastic bottle having a capacity of one liter or less may be purchased, sold, or offered for sale:

- (1) For use at any city facility, city-authorized concession, city-sponsored or city-permitted event, or city program;
- (2) By the city.

§ 34-___.3 Exemptions.

The following exemptions apply to this article:

- (1) The council, by resolution, may grant an exemption on an annual and renewable term of one year or less for specifically identified situations where the council finds that there are no reasonable alternatives to the use of a single-use plastic bottle;
- (2) The mayor may declare an emergency requiring immediate action for the preservation of life, health, property, safety, or essential public service. This exemption shall automatically be in place until the emergency has ceased or the mayor has determined that the exemption is no longer applicable to the situation;

- (3) On or before December 31, 2026, at any city facility;
- (4) On or before December 31, 2027, at any city-authorized concession, city-sponsored event, city-permitted event, or city program.

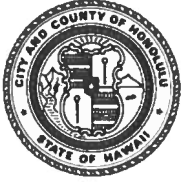
§ 34-___.4 Enforcement, civil penalties, and injunctive relief.

- (a) Enforcement and administration of this article is under the jurisdiction of the department of environmental services.
- (b) Anyone violating any provision of this article, or any rule adopted pursuant to this article, shall be ordered to obey the restrictions described by this article, and if continuing the violation despite the order, shall be subject to a civil fine of not less than \$100 nor more than \$1,000.
- (c) The director of the department of environmental services may institute a civil action in any court of competent jurisdiction for injunctive or other relief to correct or abate violations of this article, or any rule adopted pursuant to this article, to collect administrative penalties or to obtain other relief.

§ 34-___.5 Rules.

The director of the department of environmental services shall adopt rules pursuant to HRS Chapter 91 regarding the implementation, administration, and enforcement of this article."

SECTION 3. New material is underscored. When revising, compiling, or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the Revisor of Ordinances need not include the brackets, the material that has been bracketed and stricken, or the underscoring.
