RESOLUTION

CONFIRMING THE NOMINATION OF ANDREW T. KAWANO TO SERVE AS THE DIRECTOR OF BUDGET AND FISCAL SERVICES OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended ("Charter"), requires that Executive Branch department and agency heads and the Managing Director be nominated by the Mayor, subject to the advice and consent of the City Council ("Council"); and

WHEREAS, Charter Section 6-201 establishes the Department of Budget and Fiscal Services, headed by a Director of Budget and Fiscal Services; and

WHEREAS, Charter Section 6-203 sets forth the powers, duties, and functions of the Director of Budget and Fiscal Services; and

WHEREAS, Charter Section 6-202 requires that the Director of Budget and Fiscal Services shall have had a minimum of five years of training and experience in a public or private financial position, at least three years of which shall have been in a responsible administrative capacity; and

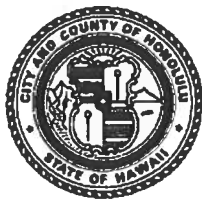
WHEREAS, Charter Section 4-104.1 requires that each department head be a registered voter of the City; and

WHEREAS, by Mayor's Message 001, dated January 2, 2025, the Mayor has nominated Andrew T. Kawano to serve as the Director of Budget and Fiscal Services; and

WHEREAS, after review of the nominee's qualifications, the Council finds that Andrew T. Kawano is qualified to serve as the Director of Budget and Fiscal Services and warrants confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Andrew T. Kawano is confirmed as the Director of Budget and Fiscal Services of the City and County of Honolulu; and
