RESOLUTION

WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended ("Charter"), requires that all department heads and the Managing Director, nominated by the Mayor, be subject to the advice and consent of the City Council ("Council"); and

WHEREAS, Charter Section 6-701 establishes the Department of Enterprise Services, headed by a Director of Enterprise Services; and

WHEREAS, Charter Section 6-702 sets forth the powers, duties, and functions of the Director of Enterprise Services; and

WHEREAS, Charter Section 4-104.1 requires that each department head be a registered voter of the City; and

WHEREAS, by Mayor's Message <u>001</u>, dated January 2, 2025, the Mayor has nominated Dita D. Simeona, also known as Dita Holifield, to serve as the Director of Enterprise Services; and

WHEREAS, after review of the nominee's qualifications, the Council finds that Dita D. Simeona is qualified to serve as the Director of Enterprise Services; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Dita D. Simeona, also known as Dita Holifield, is confirmed as the Director of Enterprise Services of the City and County of Honolulu; and
