WHEREAS, Charter Section 6-1703 sets forth the powers, duties, and functions of the Director of Transportation Services; and

WHEREAS, Charter Section 4-104.1 requires that each department head be a registered voter of the City; and

WHEREAS, by Mayor's Message \_\_\_\_\_\_, dated January 2, 2025, the Mayor has nominated J. Roger Morton to serve as the Director of Transportation Services; and

WHEREAS, after review of the nominee's qualifications, the Council finds that J. Roger Morton is qualified to serve as the Director of Transportation Services, and warrants confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that J. Roger Morton is confirmed as the Director of Transportation Services of the City and County of Honolulu; and
