RESOLUTION

WHEREAS, Section 4-104.1 of the Revised Charter of the City and County of Honolulu 1973 (Amended 2017 Edition), as amended ("Charter"), requires that all department heads and the Managing Director, nominated by the Mayor, be subject to the advice and consent of the City Council ("Council"); and

WHEREAS, Charter Section 6-1701 establishes the Department of Transportation Services, headed by a Director of Transportation Services; and

WHEREAS, Charter Section 6-1703 sets forth the powers, duties, and functions of the Director of Transportation Services; and

WHEREAS, Charter Section 4-104.1 requires that each department head be a registered voter of the City; and

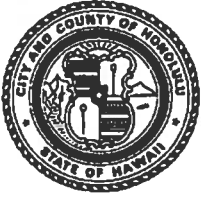
WHEREAS, by Mayor's Message 1, dated January 2, 2025, the Mayor has nominated J. Roger Morton to serve as the Director of Transportation Services; and

WHEREAS, after review of the nominee's qualifications, the Council finds that J. Roger Morton is qualified to serve as the Director of Transportation Services, and warrants confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that J. Roger Morton is confirmed as the Director of Transportation Services of the City and County of Honolulu; and
