WHEREAS, Charter Section 14-105, establishes the position of an Executive Secretary to the Neighborhood Commission, to be filled by a person appointed by the Mayor and confirmed by the City Council ("Council"); and

WHEREAS, Charter Section 14-103, sets forth the powers, duties and functions of the Neighborhood Commission; and

WHEREAS, the nominee is a registered voter of the City and County of Honolulu; and

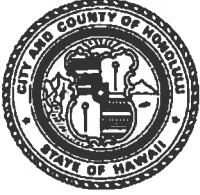
WHEREAS, by Mayor's Message 1, dated January 2, 2025, the Mayor has nominated Lloyd M. Yonenaka to serve as the Executive Secretary to the Neighborhood Commission; and

WHEREAS, after review of the nominee's qualifications, the Council finds that Lloyd M. Yonenaka is qualified to serve as the Executive Secretary to the Neighborhood Commission, and warrants confirmation; now, therefore,
