WHEREAS, the nominee is a registered voter of the City and County of Honolulu; and

WHEREAS, by Mayor's Message _____, dated January 2, 2025, the Mayor has nominated Lloyd M. Yonenaka to serve as the Executive Secretary to the Neighborhood Commission; and

WHEREAS, after review of the nominee's qualifications, the Council finds that Lloyd M. Yonenaka is qualified to serve as the Executive Secretary to the Neighborhood Commission, and warrants confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that Lloyd M. Yonenaka is confirmed as the Executive Secretary to the Neighborhood Commission of the City and County of Honolulu; and
