WHEREAS, pursuant to Charter Section 13-103, the members of the Commission are appointed by the Mayor and confirmed by the City Council ("Council") and serve for staggered five-year terms; and

WHEREAS, by Mayor's letter, dated February 6, 2025, the Mayor has appointed Sandy Ma to the Commission; and

WHEREAS, if confirmed by the Council, Ms. Ma will fill a vacant position and serve for a term to expire on June 30, 2028; and

WHEREAS, Charter Section 13-103, which applies to the Commission, requires that appointees to all City boards and commissions be registered voters of the City; and

WHEREAS, the Council of the City and County of Honolulu has reviewed Ms. Ma's qualifications and character and finds that Ms. Ma qualifies to serve on the Commission and deserves confirmation; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the appointment of Ms. Sandy Ma to the Climate Change Commission for a term expiring on June 30, 2028; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Ms. Ma for her willingness to be considered for public service and actively participate in city government; and
