CONFIRMING THE REAPPOINTMENT OF ELIZA TALBOT MANCHESTER TO SERVE ON THE ECONOMIC REVITALIZATION COMMISSION OF THE CITY AND COUNTY OF HONOLULU.

WHEREAS, Section 6-109, Revised Charter of the City and County of Honolulu, 1973 (2017 Edition), as amended ("Charter"), establishes an Economic Revitalization Commission ("Commission") consisting of nine members; and

WHEREAS, Charter Section 6-109, sets forth the duties of the Commission; and

WHEREAS, pursuant to Charter Section 13-103, the members of the Commission are appointed by the Mayor and confirmed by the City Council ("Council") and serve for staggered five-year terms; and

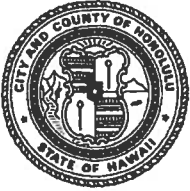
WHEREAS, by Mayor's letter, dated February 6, 2025, the Mayor has reappointed Eliza Talbot Manchester for a second term to expire December 31, 2029; and

WHEREAS, Charter Section 13-103 requires that each appointee to the Commission be a registered voter of the City; and

WHEREAS, the Council of the City and County of Honolulu has reviewed Ms. Eliza Talbot Manchester's qualifications and character and finds that she qualifies to serve on the Commission; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it confirms the reappointment of Eliza Talbot Manchester for a second term to expire December 31, 2029; and

BE IT FURTHER RESOLVED that the Council expresses its gratitude and appreciation to Ms. Eliza Talbot Manchester for her commitment and willingness to actively participate in city government; and
