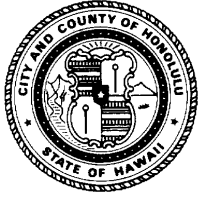


**SUMMARY OF PROPOSED COMMITTEE DRAFT:**  
**BILL 31 (2025)**  
**RELATING TO THE TRANSIT CONSTRUCTION MITIGATION FUND.**

**The PROPOSED CD1** makes the following amendments:

- A. Amends SECTION 2 of the bill as follows:
  - 1. In ROH Section 6-55.5(a)(2), replaces the proposed annual revenue maximum of \$2,000,000 with \$1,000,000.
  - 2. Removes in its entirety ROH Section 6-55.5(a)(3), which required a qualified business to have 15 or fewer employees. Renumbers the subsequent subdivision accordingly.
  - 3. In renumbered ROH Section 6-55.5(a)(3), replaces the requirement that an applicant must have opened for business prior to January 1, 2022 with a new requirement that the applicant must have opened for business at least 12 months prior to the start of any Rail Project construction within the transit construction mitigation zone in which the business is physically located, as determined by the Director of Budget and Fiscal Services.
- B. Makes miscellaneous technical and nonsubstantive amendments.

RELATING TO THE TRANSIT CONSTRUCTION MITIGATION FUND.

BE IT ORDAINED by the People of the City and County of Honolulu:

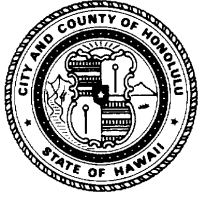
SECTION 1. Purpose. The purpose of this ordinance is to address the Transit Construction Mitigation Fund.

SECTION 2. Section 6-55.5, Revised Ordinances of Honolulu 2021, is amended to read as follows:

**"§ 6-55.5 Criteria.**

- (a) To qualify for an expenditure under § 6-55.4, an applicant must, at a minimum:
- (1) Be a business that is majority-owned by city residents and that does business with customers primarily at a physical location located within a city block in which there is active construction on the Rail Project at the time of application;
  - (2) Generate [~~not more than \$750,000~~] \$1,000,000 or less in annual revenue; and
  - ~~[(3) Have 15 or fewer employees; and~~
  - ~~(4)]~~ (3) Have opened for business [prior to January 1, 2022.] at least 12 months prior to the start of any Rail Project construction within the transit construction mitigation zone in which the business is physically located, as determined by the director of budget and fiscal services.
- (b) The director of budget and fiscal services may establish additional selection criteria for applicants under this section, including determinations on applicant viability."

SECTION 3. Ordinance material to be repealed is bracketed and stricken. New material is underscored. When revising, compiling, or printing this ordinance for inclusion in the Revised Ordinances of Honolulu, the Revisor of Ordinances need not include the brackets, the material that has been bracketed and stricken, or the underscoring.

**Report Title:**

Transit Construction Mitigation Fund; Budget and Fiscal Services ("BFS")

**Description:**

Changes eligibility for the Transit Construction Mitigation Fund by increasing the maximum allowed annual revenue to \$1,000,000; removing the number of employees limit; and by requiring the business to have opened at least 12 months prior to the start of any Rail Project construction within the transit construction mitigation zone in which the business is physically located, as determined by the BFS Director.
