In response to Councilmember Menor, Duane Pang, Deputy Corporation Counsel, Department of the Corporation Counsel stated that:

 Bill 89 (page 21) and Bill 85 (page 7) restricts the rental agreement to less than 30 days and does not mention occupancy. Physical occupancy is not required for the full 30 days.

 Both measures would not allow more than one rental agreement of 30 days or more covering the same 30 days, as permitted under the current law.

RECESS/RECONVENE

At 5:40 p.m., the Chair called for a short recess and reconvened the meeting at 5:48 p.m.

Councilmember Menor noted that his preference would be to pass Bill 85, CD2. He stated that today's vote is critical to the future of our island and the Council has an opportunity to send to the Mayor a measure that is reasonable, balanced and legally defensible. Councilmember Menor expressed his concern with problems associated with illegal vacation rentals and stated that the Council needs to address the issue now. He noted that illegal vacation rentals have reduced the inventory of housing and has contributed to the high cost of living. Councilmember Menor pointed out that the tourists staying in illegal short term rentals spend less than those staying in hotels which affects Oahu's economy. He stated that the measure would allow for the registration of a reasonable number of additional short term rentals while ensuring that rentals are effectively regulated, helping to preserve the integrity of zoning laws. Councilmember Menor stated that the passage of Bill 89, CD2 will bring relief to residents, allowing them to reclaim their neighborhoods which have been overrun by illegal short term rentals. He asked councilmembers to support the measure.

Councilmember Waters thanked all the testifiers for coming out to testify. He pointed out that Bill 85 and Bill 89 would make existing laws enforceable. Councilmember Waters voiced his support of Bill 85 and Bill 89. He noted that in 1989 there was a moratorium and anyone or any business that owned or operated a short term rental without a permit is illegal. Councilmember Waters stated that he would like the implementation date to be extended to January 1, 2020 to give the Department of Planning and Permitting time and to allow existing reservations to be honored.

Councilmember Elefante spoke in support of the measure. He thanked Chair Anderson for his hard work when serving as the Chair of the Planning Committee and Councilmember Menor for his leadership and hard work. Councilmember Elefante noted that this was not an easy issue and the City needs to strike a balance between being a tourist destination and a home to local residents. He expressed the need for Bill 89, CD2 to provide enforcement and regulation with penalties. Councilmember Elefante thanked all the testifiers that came to testify and share their stories. He stated that he is in support of the measure and thanked everyone for their hard work and input on the measure.

Councilmember Elefante noted for the record that he filed Disclosures of Interest with the City Clerk's Office (CC-129, CC-175, CC0176, CC-211, CC-212, CC-215, CC-219).

Committee Report 185 was adopted and Bill 89 (2018), CD2 passed third reading, as amended.

THIRD READING

BILL 85 (2018), CD2 - COMMITTEE REPORT 184

A BILL FOR AN ORDINANCE RELATING TO VACATION RENTALS.

Councilmember Menor moved that Committee Report 184 be adopted and Bill 85 (2018), CD1 pass third reading, as amended to CD2. Seconded by Councilmember Waters.

The following individuals testified:

Councilmember Menor noted that his remarks offered in support of Bill 89, CD2 were applicable to Bill 85, CD2 and that the same enforcement provisions are contained in both measures.

In response to councilmembers, Duane Pang, Deputy Corporation Counsel, Department of the Corporation Counsel (COR) stated that:

• There is a conflict between the two master use tables which the Department of Planning and Permitting (DPP) would have to enforce.

- The Mayor has the authority to veto either or both Bills.
- If both measures are enacted into ordinances, there would be a conflict and both may not be enforceable.

Councilmember Elefante stated that he has concerns with the master use table as COR stated there would be a conflict.

Councilmember Tsuneyoshi noted she shares the concerns of Councilmember Elefante. She stated that the Council has spent a lengthy amount of time and energy and should make a decision showing that everyone has come together to pass out a Bill and not pass out two pieces of legislation that conflict. She urged councilmembers to move forward and not create any more confusion on this issue.

Councilmember Elefante asked the introducers of the measure if they would entertain a motion to defer Bill 85, CD2.

Councilmember Menor stated that his position has been that both measures provide alternative approaches. He noted that the issue is of significant importance and further dialog in considering both approaches would be appropriate.

Councilmember Manahan stated that his preference was to move Bill 85 but that he also supports Bill 89. He noted that if there is going to be a conflict for the DPP to enforce then he would entertain a motion to defer.

Councilmember Elefante moved to defer action on Bill 85, CD2. Seconded by Councilmember Manahan.

RECESS/RECONVENE

At 6:09 p.m., the Chair called for a short recess and reconvened the meeting at 6:10 p.m.

Councilmember Elefante moved to postpone the Bill to a meeting date to be determined by the Council Chair. Seconded by Councilmember Menor.

Councilmember Tsuneyoshi emphasized that the amount of time and energy the Council has gone through to get to this point. She thanked everyone for coming to testify and stated that the Council came together to make a decision that they felt was the best to enforce the zoning laws and for future generations to be able to afford to live and raise a family here. Councilmember Tsuneyoshi expressed her concern that the Council should make a decision on Bill 85. She noted that she is opposed to deferring action on Bill 85, CD2.

Chair Anderson urged councilmembers to keep in mind that the Corporation Counsel has stated that there is a conflict between the two Bills.

Councilmember Elefante stated that the reason he made the motion to defer the measure was because of the testimony from COR that stated Bill 85, CD2 would amend the same section of Bill 89, CD2 and would cause a conflict.

Councilmember Elefante noted for the record that he filed Disclosures of Interest with the City Clerk's Office [CC-337(18), CC-130, CC-210, CC-213, CC-214, CC-218].

The motion to postpone the Bill failed due to lack of a majority vote.
